2024-25 LA KINGS BIRTHDAY CLUB

Terms and Conditions

NO PURCHASE IS NECESSARY TO REGISTER. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

2024-25 LA KINGS BIRTHDAY CLUB: The 2024-25 LA Kings Birthday Club ("Club") rewards eligible participants who register for the Club with a special birthday gift delivered via email as set forth herein.

- 1. Eligibility. The Club is open only to legal residents of California, who are 18 years of age or older at time of registration. Birthday email will be sent by the LA Kings to the email address contained in the Member's registration on or around the 1st day of the Member's birthday month, except for Members with birthdays in the NHL Off-Season months of May 2024 through September 2024, which emails will be sent by the LA Kings on or around September 1, 2024. Registrations received from any person or e-mail address in excess of the stated limitation will be void. Game shall be played at Crypto.com Arena in Los Angeles, CA; (ii) a code for ten percent (10%) off merchandise good <u>only</u> at the Team LA online store located at: https://teamlastore.com (restrictions may apply); and (iii) a surprise percentage off code good only for the online purchase (at https://www.nhl.com/kings) of additional tickets to the Game. The purchase of additional tickets to the Game must be made at the same time as Member redeems the birthday code for their complimentary tickets for the Game. Surprise percentage off code will be shown at time of redeeming your birthday code and the amount of the percentage off shall be determined by the LA Kings in its sole discretion.
