

BOSTON BRUINS FAN FEST TOUR 2024
TERMS & CONDITIONS

I, on behalf of myself and my participating minor child (if any), in consideration for the opportunity to participate in the 2024 Bruins Fan Fest ("Event") hosted by the Boston Professional Hockey Association, Inc. ("Bruins"), hereby agree as follows:

I acknowledge that there are certain risks associated with participation in the Event and use of the facilities. These risks include the danger of personal injury or property damage while undertaking activities involving combine-style exercises, other Event participants, and hockey pucks, sticks, and other equipment.

I hereby (i) assume all risks and danger of personal injuries and all other hazards arising from or related in any way to my or my child's participation in the Event and use of the facilities in connection therewith, whether occurring prior to, during, or after the Event, (ii) agree to indemnify and hold harmless the Bruins, Boston Bruins Charitable Foundation Inc., Delaware North Companies, Inc. – Boston, the facility owner and operator, the respective parent, subsidiary, affiliated, and related companies of each, and the directors, officers, stockholders, employees, contractors, agents, and representatives of each (collectively the "Entities") against any liability, loss, damage, expense, claim, demand, cause of action, settlement, or judgment of any kind or nature (including reasonable attorneys' fees) ("Loss") arising directly or indirectly from or related to my or my child's participation in the Event and access and use of the facilities in connection therewith, and (iii) release and discharge the Entities from any and all claims whatsoever in connection with my or my child's participation in the Event and access and use of the facilities in connection therewith, including claims for personal injury or death or property damage suffered by me or my child; provided, however, that this indemnification and release shall not apply to the extent that a Loss, injury, death, or property damage results directly from the gross negligence or willful misconduct of one or all of the Entities.

PHOTO RELEASE

I, on behalf of myself and my child hereby grant the Bruins permission to use my and my child's image, likeness, actions, voice, and/or statements in any live or recorded audio, video, or photographic display or other broadcast, transmission, exhibition, or reproduction made of or at the Event for any purpose and in any medium without authorization or compensation. In connection with the foregoing, I hereby authorize the Bruins to edit, alter, exhibit, publish or distribute such works, and make derivative works thereof. In addition, I waive the right to inspect or approve any work in which my or my child's image, likeness, actions, voice, and/or statements appears. I understand and agree that such works will be the property of the Bruins. I hereby hold harmless and release and forever discharge the Entities from any and all Loss which I, my child, and our heirs, representatives, executors, administrators, or any other persons acting on my or my child's behalf or on behalf of my or

my child's estate, have or may have by reason of this authorization, including any claim for invasion of privacy, violation of right of publicity, defamation, or appropriation, or any similar claim, in connection with any such use.

I hereby certify that I am at least 18 years of age. If I have a participating minor child, I certify that I am such child's parent or legal guardian, with full power and authority to execute this waiver and release and perform such obligations on my child's behalf.

I have read and fully understand and agree to the foregoing.

For Plymouth, MA Fan Fest participants:

I, the adult participant or parent/guardian of the child participant, have been made aware that the Town of Plymouth, the Recreation Department, and its related parties, are not covered by insurance for persons injured while taking part in the Bruins Fan Fest. In consideration of my or my child's upcoming participation, I hereby hold the Town, its servants and employees and related parties harmless from any injury I or my child may incur during said participation. I agree to hold harmless the Town of Plymouth, the Recreation Department, its servants and employees, its related parties and the doctor/clinic/hospital treating me or my child for failure to obtain my consent. I further grant authorizations for any pictures taken of me or my child to be used for publicity and promotional purposes.
