PITTSBURGH PENGUINS SUMMER 2024 SEASON TICKET HOLDER APPRECIATION WEEK SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.

- 1. **SWEEPSTAKES PERIOD**: The Pittsburgh Penguins Summer 2024 Season Ticket Holder Appreciation Week Sweepstakes (the "Sweepstakes") will begin on July 25, 2024 at 9:00 a.m. Eastern Time ("ET") and ends on July 28, 2024 at 11:59 a.m. ET (the "Sweepstakes Period"). Sponsor's clock is the official clock of the Sweepstakes.
- 2. **ELIGIBILITY:** The Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia, who are at least eighteen (18) years of age or older at the time of entry. Employees and directors of the Pittsburgh Penguins LP ("Sponsor") and its parent and subsidiary companies, affiliates, divisions, franchisees, representatives, consultants, sub-contractors, suppliers, distributors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies and members of their immediate families (defined for these purposes as including spouse, parents, children, and siblings and each of their respective spouses) and individuals living in the same household, are not eligible to participate. By submitting the completed Form during the Sweepstakes Period, you will receive one [1] entry into the Sweepstakes.
- b. Mail-In Method: Entrants may also enter the Sweepstakes by printing his or her name, address, city, state, zip code, email address (optional), age, and day and evening telephone numbers on a postcard and mailing to: "The Pittsburgh Penguins Summer 2024 Season Ticket Holder Appreciation Week Sweepstakes", Pittsburgh Penguins LP, 1001 Fifth Avenue, Pittsburgh, PA 15219. Entry by mail must be postmarked on date no earlier than the start of the Sweepstakes Period and no later than the last date of the Sweepstakes Period, and received no later than the Date of Drawing (defined below).

Entries may or may not be acknowledged, in Sponsor's sole discretion. LIMIT: ONE [1] ENTRY PER PERSON, REGARDLESS OF METHOD OF ENTRY, FOR THE ENTIRE SWEEPSTAKES PERIOD. Entries received before or after the Sweepstakes Period will not be accepted or be eligible to win the Prize. Multiple entrants are not permitted to share an email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email accounts, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified from the entire Sweepstakes. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the

email account used to register will be deemed to be the registrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. - 4. WINNER SELECTION: On or about July 29, 2024 (the "Date of Drawing"), Sponsor will randomly select two (2) potential winners from among all eligible entries received. AN ENTRANT IS NOT A WINNER OF ANY PRIZE, EVEN IF THE SWEEPSTAKES SHOULD SO INDICATE, UNLESS AND UNTIL ENTRANT'S ELIGIBILITY AND COMPLIANCE WITH THE OFFICIAL RULES HAVE BEEN VERIFIED AND ENTRANT HAS BEEN NOTIFIED THAT VERIFICATION IS COMPLETE. Prize Restrictions and Delivery: No cash or other substitution or exchange of Prize is permitted, except at Sponsor's sole discretion. Limit: one [1] Prize per person. Prize 1 will be shipped to the address provided to Sponsor during entry within four (4) to six (6) weeks following the end of the Sweepstakes Period. Prize 2 will be added to the My Penguins Account (www.pittsburghpenguins.com/myaccount) associated to the email address provided to the Sponsor during entry at least 72 hours prior to game time. Winners agree that the Prize is personal and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed. - 8. RELEASE OF LIABILITY: By participating in this Sweepstakes, entrants agree to be bound by the Official Rules and the decisions of Sponsor. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsors reserve the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
