## NHL NAMES COLIN CAMPBELL SENIOR VICE PRESIDENT, DIRECTOR OF HOCKEY OPERATIONS

**NEW YORK (July 20, 1998)** – National Hockey League Commissioner Gary Bettman announced today the appointment of Colin Campbell to the position of NHL Senior Vice President and Director of Hockey Operations.

A native of London, Ontario, Campbell played 11 NHL seasons with Pittsburgh, Colorado, Edmonton, Vancouver and Detroit before devoting 13 seasons to coaching.

Campbell was an assistant coach for five seasons with the Detroit Red Wings, then served eight seasons with the New York Rangers' organization. He began as an assistant coach with the Rangers, later became head coach of the team's American League affiliate in Binghamton, N.Y., then returned to New York as an associate coach during the Rangers' Stanley Cup season in 1993-94. Campbell was the Rangers' head coach from 1994-95 to 1997-98 and steered his team into at least the second round in each of his three full seasons.

In the course of his 24 professional seasons, Campbell was a teammate of such legends as Wayne Gretzky and Mark Messier. He was a player under such coaching standouts as Glen Sather and Roger Neilson. He assisted such coaches as Jacques Demers and Mike Keenan. He coached such current stars as Brian Leetch, Mike Richter, Steve Yzerman and Gretzky.

"By playing with and against hockey's greatest players, coaching with and against some of hockey's greatest minds, there is no doubt that Colin Campbell has a keen awareness of every aspect of the game," NHL Commissioner Gary Bettman said. "His extensive background and unique perspective make Colin an ideal person to help guide the game's future."

Campbell, 45, will work closely with Commissioner Bettman and the League's General Managers. He will be responsible for the administration of supplementary discipline and will oversee the League's on-ice officials.

Campbell was the 27th player selected in the 1973 draft, which also produced future Hall of Famers Denis Potvin, Lanny McDonald and Bob Gainey. During a playing career that began in Pittsburgh during the 1974-75 season, Campbell played 636 regular-season NHL games. He scored 25 goals, added 103 assists and collected 1,292 penalty minutes. He also competed in 45 playoff contests and helped the Vancouver Canucks reach the Stanley Cup Finals against the New York Islanders in 1982.

Campbell and his wife, Heather, reside in Westchester County with their two daughters, Lauren and Courtney, and son Gregory.
