Hath's Heroes December Sweepstakes Official Rules December 2, 2025 – December 31, 2025

- 1. ELIGIBILITY: The Hath's Heroes December Sweepstakes (the "Sweepstakes") is only open to entrants who are legal residents of the United States residing in Pennsylvania, New Jersey or Delaware, and who are 18 years of age or older as of the date of entry. Entries generated by script, macro or other automated or mechanical means and entries generated by any other means which subvert the entry process will be void. Any attempt by any person to obtain more than the stated number of entries will void all of that person's entries and that person will be disqualified. No entries will be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Sponsor.

- 4. DRAWING AND NOTIFICATION: One (1) potential winner will be drawn at random on January 13, 2026 from among all eligible entries received. Sponsor reserves the right to delay the drawing. The drawing will be conducted under the supervision of Sponsor, whose decisions are final. The potential winner will be notified via email and/or telephone (in Sponsor's discretion).
