

VEGAS GOLDEN KNIGHTS READING WEEK 2025 OFFICIAL RULES

SPONSORED BY ZAPPOS

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE VEGAS GOLDEN KNIGHTS READING WEEK 2025 SWEEPSTAKES (the "Sweepstakes"). A purchase will not increase your chances of winning.

By entering into the Sweepstakes, each participant unconditionally accepts and agrees to comply with and abide by these official rules ("<u>Official Rules</u>") and the decisions of Zappos.com LLC d/b/a Zappos ("<u>Sponsor</u>" or "SPONSOR") and Black Knight Sports and Entertainment LLC d/b/a Vegas Golden Knights ("BKSE") which shall be final and binding in all matters relating to this Sweepstakes.

The Sweepstakes will begin at 10:00 AM PST on January 27, 2025, and will end at 5:00 PM PST on February 14, 2025 ("<u>Sweepstakes Period</u>"). SPONSOR'S servers and clock shall serve as the official clock for the Sweepstakes and participants' proof of submission does not constitute proof of receipt by SPONSOR.

1. <u>Eligibility</u>. To be eligible to compete in the Sweepstakes, participant must be an employee/teacher of a PreK -5^{th} grade school or class with a school mailing address located in the Clark County School District during the Sweepstakes Period. Any attempt by any person to submit more than one entry will void all of that person's entries and that person will be disqualified. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of SPONSOR, BKSE, National Hockey League ("NHL"), other NHL teams ("NHL Entities"), and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes (collectively, "<u>SPONSOR Entities</u>") are not eligible to enter or win. 2. <u>How to Enter</u>. To enter the Sweepstakes each participant must complete a nomination form, found on the Vegas Golden Knights website under the Community tab or at <u>readingweek@vegasgoldenknights.com</u>.

All entries must comply with the entry criteria set forth herein, be fully completed and received by the conclusion of the Sweepstakes Period and must comply with these Official Rules – ONE ENTRY PER PERSON. No other method of entry is acceptable. In the event of a dispute as to the identity or eligibility of a winner based on an e-mail address, the winning entry will be declared made by the "Authorized Account Holder" of the e-mail address submitted at the time of entry, provided he/she is eligible according to these Official Rules. The "Authorized Account Holder" is defined as the natural person to whom the applicable Internet service provider or other organization (such as a business or educational institution) has assigned the e-mail address for the domain associated with the submitted e-mail address.

Any attempt by any participant to obtain more than one entry by using multiple/different email addresses, identities, or any other methods will void that participant's entry and that participant may be disqualified. Entries will become the property of SPONSOR and will not be returned or acknowledged.

Each participant agrees to take, at SPONSOR'S expense, any further action (including without limitation, execution of affidavits and other documents) reasonably requested by SPONSOR and/or BKSE to effect, perfect or confirm SPONSOR'S and BKSE's rights as set forth in this Paragraph 3.

4. <u>Winner Selection</u>. On or about February 18, 2025, twenty (20) potential winners will be selected by SPONSOR based on the originality and creativity of their response on why their class or school deserves a reading week visit.

5. <u>Winner Notification</u>. Each potential winner will be notified by SPONSOR via email using the email address provided at time of entry during the week of February 17, 2025. SPONSOR will make three (3) attempts to contact the potential winner by the method described above within three (3) business days after they were determined to be the potential winner. If SPONSOR is unable to reach the winner by the method described above within five (5) days of SPONSOR'S first notification, that potential winner will be disqualified and an alternate potential winner will be determined from all remaining eligible entries based upon the criteria described in these Official Rules.

All potential winners are subject to verification by Sponsor, whose decisions are final and binding. Potential winners may be required to complete, except where prohibited, an Affidavit of Eligibility/Liability/Publicity Release and may also be required to submit completed liability and publicity releases for individuals participating in the Prize (the "Winner Documents").
