# Carolina Hurricanes Foundation 50/50 Raffle

#### **OFFICIAL RULES**

1. The Carolina Hurricanes Foundation will conduct 50/50 raffles at Hurricanes Home games during the raffle periods outlined below.

## Ticket prices:

- 2 tickets for \$5
- 5 tickets for \$10
- 20 tickets for \$20
- 80 tickets for \$40
- Multi-ticket discounts are only available for purchases made at the same time.
- The ticket pricing is subject to change based on special promotions or deals for individual events.
- 2. ELIGIBILITY. Participants must be (i) eighteen (18) years of age or older, (ii) legal U.S. residents, and (iii) present in the State of North Carolina at the time of ticket purchase in order to be eligible to win any prize(s). Participants do not need to be present at the drawings to win any prize. Volunteers, employees, directors, officers, temporary or contract employees, and agents of Carolina Hurricanes Foundation, Inc. ("Sponsor"), Hurricanes Hockey Limited Partnership, Hurricanes Holdings, L.L.C., DCP HH LLC, and each of their respective affiliates, subsidiaries, and advertising or promotional agencies (collectively, the "Promotion Entities") and immediate family members and members of the household of such employees are not eligible to win.   - ii. at the Carolina Hurricanes Foundation kiosk located at section 129 on the concourse and throughout PNC Arena via mobile ticket sellers from the time that doors open (normally seventy five minutes prior to game time), for each Carolina Hurricanes home game during the Raffle Period, until the beginning of the third period, or shortly thereafter.
- 4. PRIZES.
  - a. **Grand Prize.** One (1) grand prize of fifty percent (50%) of the net proceeds (gross proceeds less direct hardware and software licensing costs) from the cumulative sale of Raffle tickets during the Raffle Period will be awarded for each Raffle (the "Grand Prize"). The Grand Prize will be, in accordance with North Carolina law, a maximum of One Hundred Twenty-Five Thousand dollars

(\$125,000). The Carolina Hurricanes Foundation will receive the remaining balance of the net proceeds.

## WINNER SELECTION.

- a. The Grand Prize winning ticket for each Raffle Period will be randomly selected during the 3rd period of the final Hurricanes game of the Raffle Period (i.e. Saturday, December 23, 2023 vs. New York Islanders).
- **b.** The winning ticket numbers will be announced online at www.Hurricanes.com/5050, www.Canes5050.com, and on Twitter under @CanesGiveBack. Winners need not be present at the applicable drawing to win or claim any prize.
- 6. ODDS OF WINNING. The odds of winning depend on the total number of Raffle tickets sold.
- 7. WINNER NOTIFICATION/RELEASES. The winning ticket numbers will be displayed at www.hurricanes.com/5050 and www.Canes5050.com within one (1) business day after the selection of each respective Grand Prize winning number. In order to claim a Raffle prize, potential winners should contact a Carolina Hurricanes Foundation representative at the Carolina Hurricanes Foundation kiosk outside section 129 on the main concourse of PNC Arena or by calling 919-861-5474. Official Carolina Hurricanes Foundation 50/50 Raffle tickets are the only valid receipts and the only acceptable proof allowed for claiming a prize.
