## KINGS NOTES

- Forward **Quinton Byfield** (1-0=1) scored his 20th goal of the season, matching his single-season career-high for goals set last season. With the goal, Byfield becomes the eight different skater selected in the 2020 NHL Draft to record multiple 20-goal seasons.
- Per NHL PR, Byfield became the second Kings player over the past 35 years to record multiple 20-goal seasons at age 22 or younger. **Anze Kopitar** reached the mark four times prior to turning 23 (2006-07 – 2009-10).
- Byfield has now scored in back-to-back home games against the Seattle Kraken (1-0=1; Nov. 23, 2024).
- Forward **Alex Laferriere** (0-1=1) recorded his 21st assist of the campaign, marking the 60th point of his career (28-32=60) and his first career point against the Seattle Kraken.
- Defenseman **Kyle Burroughs** (0-1=1) picked up his third helper of the season on Byfield's game-opening goal.
