

OFFICIAL RULES

PITTSBURGH PENGUINS APRIL 2025 GLASS SEATS TICKET SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW. MUST BE 18 YEARS OF AGE OR OLDER TO ENTER. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING THE SWEEPSTAKES PERIOD.

ELIGIBILITY: Pittsburgh Penguins April 2025 Glass Seats Ticket Sweepstakes (the “Sweepstakes”) is open only to legal residents of the Commonwealth of Pennsylvania, Ohio, and West Virginia who are at least 18 years old at the time of entry. Void in all other jurisdictions and where prohibited by law. Employees (and their immediate families) of Pittsburgh Penguins LP (the “Sponsor”), the National Hockey League (“NHL”), its member clubs, NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises B.V., NHL Interactive CyberEnterprises, LLC (the foregoing NHL entities collectively, the “NHL Entities”), the National Hockey League Players’ Association (“NHLPA”), Hockey Ventures (Canada) Inc. (the foregoing NHLPA entities collectively, the “NHLPA Entities”) and any of their respective parents, subsidiaries, affiliates, suppliers, independent contractors, members and agencies, (cumulatively, the “Sweepstakes Entities”) and the immediate families and any persons living in the same household of such parties (whether related or not) are not eligible to participate in the Sweepstakes. Immediate family is defined as a parent; sibling; child by blood, adopted, or marriage; spouse; grandparent or grandchild. Sweepstakes is subject to all applicable federal, state, local laws and regulations and is void where prohibited by law. By participating, entrants agree to these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes.

TIMING: The Sweepstakes begins on February 18, 2025 at 10:00 a.m. Eastern Standard Time (“EST”) and ends March 28, 2025 at 11:59 p.m. Eastern Standard Time (“EST”) (the “Sweepstakes Period”). Prize winner will be selected in a random drawing on or around April 4, 2025 from all eligible entries received during the Sweepstakes Period. Sponsor’s clock is the official clock for the Sweepstakes.

HOW TO ENTER: There are two (2) ways to enter the Sweepstakes. You may enter the Sweepstakes via purchasing an Eligible Plan (as defined below) or by email. No other method of entry will be accepted. Limit one (1) entry per person/household, regardless of method of entry. Additional entries beyond the specified limit will be void. All entries become the property of Sponsor.

(1) Season Ticket Purchase Method: During the Sweepstakes Period, an individual will be entered by purchasing a new Pittsburgh Penguins full season (approximately forty-four (44) games) ticket package (“Eligible Plan”) for the 2025-2026 season. By successfully purchasing a new Eligible Plan during the Sweepstakes Period, you will be entered in the Sweepstakes. All individuals who have purchased a new Eligible Plan by the end of the Sweepstakes Period will be automatically entered into this Sweepstakes.

(2) Email Method: If you do not wish to enter by purchasing a new Eligible Plan, you may enter the Sweepstakes by emailing your full name, address, city, zip code, day & evening telephone numbers (including area codes), and date of birth and the following statement: “I acknowledge that I have read, understand, and agree to the Sweepstakes Official Rules.” Such email shall be sent to tickets@pittsburghpenguins.com with the name of the Sweepstakes as the email subject line. Sponsor will use email addresses for prize notification purposes only.

PRIZE AND ODDS OF WINNING: There will be one (1) drawing to select one (1) winner from all eligible entries. The prize shall consist of two (2) tickets to three (3) Pittsburgh Penguins home games (as further outlined below). The tickets will be located against the glass at a location to be determined by Sponsor. The tickets will be for the following games:

April 8, 2025 – Chicago Blackhawks

April 13, 2025 – Boston Bruins

April 17, 2025 – Washington Capitals

The Approximate Retail Value (“ARV”) of the prize is \$3,000.00. The winner of the prize must be able to attend each game.

The difference between any stated value and actual value will not be awarded to the winner. The random drawing, selection of winner, and awarding of the prize will be conducted under the supervision of Sponsor whose decisions are final and binding in all matters pertaining to this Sweepstakes. No prize substitution will be allowed, except that Sponsor reserves the right to substitute a prize of comparable value if the prize listed is unavailable for any reason. Odds of winning depend on the number of eligible entries received. All prize details are at Sponsor’s sole discretion.

Prize winner will receive an Internal Revenue Service Form 1099 for the ARV of the prize for the tax year in which the prize was awarded and agree to fully cooperate with Sponsor and its representatives as to its compliance with all applicable governmental reporting requirements, including by providing upon request his/her Social Security Number via Internal Revenue Service Form W9.

WINNER NOTIFICATION: Potential prize winner will be notified by email and will receive a telephone call if such email has not been responded to within twenty-four (24) hours of receiving such email. Potential prize winner will also be required to sign and return an Affidavit of Eligibility and Release of Publicity and Liability (where permitted by law) within three (3) days of notification. Winner’s age is subject to independent age verification, and if failed, will result in prize forfeiture. In the event of noncompliance, if the prize winner cannot be reached at the phone number, email address or address on that winner’s entry, or if the prize or prize notification is returned unclaimed or undeliverable for whatever reason beyond the control of Sponsor, that prize will be forfeited, and an alternate winner may be selected only if time permits and in Sponsor’s sole discretion.

GENERAL TERMS: Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.

FORCE MAJEURE: Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes, in whole or in part, if it determines, in its sole discretion, that the Sweepstakes or any particular Sweepstakes drawing is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Sweepstakes or particular sweepstakes drawing as contemplated herein. In the event Sponsor is prevented from awarding prizes or continuing with the Sweepstakes or a particular Sweepstakes drawing as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failures, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis (e.g. SARS), order of any court of jurisdiction, or other cause not reasonably within Sponsor's control (each a "Force Majeure" event or occurrence), then subject to any governmental approval which may be required, Sponsor shall have the right to modify, suspend, or terminate the Sweepstakes in its entirety or the affected portion of the Sweepstakes.

DISPUTES, ARBITRATION AND CHOICE OF LAW: Except where prohibited by law, as a condition of participating in this Sweepstakes, entrant agrees to the following: (1) any and all disputes and causes of action arising out of or connected with this Sweepstakes, or any prizes awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA regional office in Pittsburgh, PA; (2) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with entering this Sweepstakes), and entrant further waives all rights to have damages multiplied or increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the right and obligation of entrants and Sponsor in connection

with this Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the Commonwealth of Pennsylvania, USA, without regard to Pennsylvania's choice of law provisions.
