

NY RANGERS “WINTER CLASSIC FAN FIRST” SWEEPSTAKES (the “Sweepstakes”)

OFFICIAL RULES

**NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.
A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

1. **PERIOD:** Sweepstakes begins at 11:00 a.m. Eastern Time (“ET”) on December 13, 2025 and ends at 11:59 p.m. ET on December 29, 2025 (the “Sweepstakes Period”).
2. **ELIGIBILITY:** Sweepstakes is open to legal U.S. residents of New York, New Jersey and Connecticut, at least eighteen (18) years old at time of entry and who reside within a 75-mile radius of the arena at Madison Square Garden. Sweepstakes is void outside the area stated herein and where prohibited by law. Directors, employees, and the immediate family (spouses, parents, siblings, children, grandparents or grandchildren and their respective spouses, regardless of where they reside) and/or household members of individuals, whether or not related, employed by New York Rangers, LLC (the “Rangers”), MSG Sports, LLC (“Sponsor”), MSG Entertainment Holdings, LLC (MSG Sports, LLC and MSG Entertainment Holdings, LLC are collectively referred to herein as “MSG”), the National Hockey League and its member teams, NHL Enterprises, L.P. (collectively, “NHL Entities”) and all of their respective parents, subsidiaries, affiliates, directors, officers, employees, advertising and promotional agencies, are ineligible to participate. Sweepstakes is subject to all applicable MSG, federal, state and local laws, policies and guidelines. Official Rules are subject to change at Sponsor’s sole discretion. By entering, each entrant agrees to be bound by these Official Rules and the decisions of the Sponsor, which are final and binding on all matters.
3. **TO ENTER:** Limit one (1) entry per person. During the Sweepstakes Period, individuals who sign up and are verified for Sponsor’s Fan First program here, <https://www.nhl.com/rangers/tickets/fan-first>, will be entered for a chance to win.

Multiple entries from any person will be void. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. All entries become the property of Sponsor and will not be acknowledged or returned.

4. **SELECTION OF WINNER:** Sponsor will randomly select one (1) potential winner after the Sweepstakes Period from among all eligible entries (“Potential Winner”). Potential Winner will be notified by mobile phone or email (depending on method of entry). Potential Winner must comply with all terms and conditions of these Official Rules, and winning a prize is contingent upon fulfilling all requirements. Potential Winner (or the parent or legal guardian of such Potential Winner if applicable) may be required to sign and return an Affidavit of Eligibility, W-9 Form and Liability/Publicity Release within twenty-four (24) hours of the date of notice in order to claim his/her/their prize and become an official winner (“Official Winner”). If a prize or prize notification is returned as undelivered, prize remains unclaimed, a Potential Winner cannot be contacted, fails to sign and return the Affidavit of Eligibility, W-9 Form and Liability/Publicity Release within the required time period or is not in compliance with these Official Rules, such Potential Winner may be disqualified and forfeits the prize. In the event that a Potential Winner is disqualified for any reason, Sponsor may award the prize to an alternate Potential Winner by random drawing from among all remaining eligible entries received. Odds of winning depend on the total number of eligible entries received during the Sweepstakes Period.

5. PRIZE: One (1) Official Winner will receive one (1) New York Rangers' jersey, with all details to be determined by the Rangers and subject to availability (Approximate Retail Value ("ARV") of the prize: \$240).

Tickets (if applicable) are subject to terms and conditions stated thereon. Official Winner, and his/her/their accompanying guest (if applicable), agree to comply at all relevant times with all MSG, federal, state, city, and local rules, policies, regulations, guidelines, and laws, as may change from time to time, as may be requested or required by MSG. Failure to do so may result in forfeiture of prize.

If applicable, transportation to/from the event(s) is not included as part of the prize. Cash prizes (if applicable) may be awarded in the form of a check. If applicable, the autographed item(s) is not game used and/or game worn and the actual ARV of the autographed item(s) may vary based on market fluctuation. If applicable, individual who will autograph the prize(s) will be determined by Sponsor in its sole discretion. Prize is awarded "as is" with no warranty or guarantee, either express or implied. Official Winner will be responsible for all federal, state and local taxes and fees and other costs and expenses associated with prize receipt and/or use that are not expressly included in the prize description, including but not limited to transportation to and from the Arena, meals and beverages. PUBLICITY: Except where prohibited, participation in the Sweepstakes constitutes Official Winner's (and the parent or legal guardian of such Official Winner if applicable) consent to MSG, the NHL Entities and their respective parent, subsidiary and affiliated companies and their designees to use his/her/their name, likeness, photograph, voice, opinions, biographical information, hometown and state for advertising and promotional purposes, in any manner, in any and all media, now or hereafter devised, worldwide in perpetuity, without further payment or consideration, notification or permission.

Entrants who provide their email address will automatically be enrolled to receive emails from or on behalf of Sponsor or others and can opt out of receiving future emails at any time by following the directions provided in such emails.

GENERAL CONDITIONS: Released Parties (as defined below) are not responsible for lost, late, incomplete, inaccurate, stolen, delayed, misdirected, undelivered or garbled entries, texts, or emails, or other communications of any kind, or postage-due, damaged or illegible mail; or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitations, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prize, or in any Sweepstakes-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules, or in an unsportsmanlike or disruptive manner and void all associated entries.
