

## Infosys x New York Rangers Trivia Game

### OFFICIAL RULES

**NO PURCHASE NECESSARY. VOID OUTSIDE THE AREA STATED AND WHERE PROHIBITED.**

**ELIGIBILITY:** Game is open to legal U.S. residents of New York, New Jersey and Connecticut, at least eighteen (18) years old at the time of entry, who reside within a 75-mile radius of the arena at Madison Square Garden (“Arena”), who have downloaded the New York Rangers app (“App”) and created an account (all App terms apply). Downloading the App and creating an account is free. Game is void outside this area and where prohibited by law. Directors, employees, and the immediate family (spouse, parent, sibling, children, step-children, grandparent or grandchildren and their respective spouses, regardless of where they reside) and/or household members, whether or not related, of individuals employed by MSG Sports, LLC, MSG Entertainment Holdings, LLC (collectively, “MSG”), New York Rangers, LLC (the “Rangers” or “Sponsor”), Infosys, Ltd. (“Infosys”), the National Hockey League and its member teams, NHL Enterprises, L.P. (collectively, the “NHL Entities”), and all of their respective parents, subsidiaries, affiliates, directors, officers, employees, advertising and promotional agencies, are ineligible to participate. Game is subject to all applicable federal, state and local laws.

**ENTRY PERIOD:** The Game will run each month from September 2024 through April 2025 during the entry period identified on the App and in the call to action for the applicable month’s Game offering (the “Monthly Entry Period”). Unless otherwise provided, the Monthly Entry Period will begin at 12:01 a.m. Eastern Time (ET) on the first day of the Monthly Entry Period and end on 11:59 p.m. ET on the last day of the Monthly Entry Period.

**HOW TO PLAY:** Log into the App during each Monthly Entry Period and follow the directions to navigate to and play the Game. Game consists of five (5) trivia questions. Submit answers to all five (5) questions to receive one (1) entry for the then-current Monthly Entry Period. You do not have to answer the questions correctly to be entered but all questions must be answered for your entry to be considered. You may submit an entry during each Monthly Entry Period. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. All entries become the property of Sponsor.

**RANDOM DRAWING:** A random drawing will be held within three (3) days following the conclusion of each Monthly Entry Period (each, a “Drawing”). One (1) potential winner will be selected in each Drawing from among all eligible entries received for the applicable Drawing. Odds of winning depend on the number of eligible entries received.

**WINNER NOTIFICATION AND REQUIREMENTS:** Potential winners will be notified via email or App to complete the winner verification process. Potential winner must comply with all terms and conditions of these Official Rules, and winning a prize is contingent upon fulfilling all requirements. The potential winner may be required to sign and return an Affidavit/Declaration of Eligibility and/or Liability/Publicity Release within such time period specified in the prize notification in order to claim the prize and become an official winner (“Official Winner”). If a prize notification is returned as undelivered, a potential winner cannot be contacted or fails to

respond to the initial notification within the time period states or fails to sign and return the Affidavit/Declaration of Eligibility and Liability/Publicity Release within the required time period (if applicable), or is not in compliance with these Official Rules, such potential winner may be disqualified and forfeits the prize and, at Sponsor's discretion, an alternate winner may be selected.

**PRIZE:** Rangers merch or swag (to be determined by Sponsor) - approximate retail value ("ARV"): up to \$150. Actual value of autographed merchandise (if awarded) may vary based on market fluctuations. Prize is awarded "as is" with no warranty or guarantee, either express or implied. Winner will be responsible for all federal, state and local taxes and fees and other costs and expenses associated with prize receipt and/or use. No cash or other substitution, assignment or transfer of a prize is permitted, except by Sponsor, who reserves the right to substitute prize or prize component with cash or another prize of comparable or greater value. All prize details are at Sponsor's discretion.

**PUBLICITY:** Except where prohibited, participation in the Game constitutes winner's consent for Sponsor, MSG, Infosys, the NHL Entities, and all of their respective parent, subsidiary and affiliated companies and their designees to use his/her name, likeness, photograph (including profile photo), voice, opinions, biographical information, hometown and state for advertising and promotional purposes, in any manner, in any and all media, now or hereafter devised, worldwide in perpetuity, without further payment or consideration, notification or permission.

Entrants who provide their email address will automatically be enrolled to receive emails from or on behalf of Sponsor or others and can opt out of receiving future emails at any time by following the directions provided in such emails.

**RELEASE/LIMITS OF LIABILITY:** By entering this Game, each entrant agrees to release and hold harmless Infosys, Sponsor, MSG, the NHL Entities, and their respective parents, affiliates, subsidiaries, officers, directors, shareholders, agents, employees and all others associated with the development and execution of this Game (collectively, "Released Parties") from and against any losses, damages, rights, claims or causes of action of any kind arising, in whole or in part, directly or indirectly, out of participation in the Game or resulting directly or indirectly, from acceptance, possession, use, or misuse of the prize awarded in connection with the Game, including without limitation personal injury, death and/or property damage, as well as claims based on publicity rights, defamation and/or invasion of privacy.

Released Parties are not responsible for lost, late, incomplete, inaccurate, stolen, delayed, misdirected, undelivered or garbled entries, prize claims, emails, or other communications of any kind, or for postage-due, damaged or illegible mail; or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), App, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electric, computer, network,

typographical, printing or otherwise relating to or in connection with the Game, including, without limitations, errors or difficulties which may occur in connection with the administration of the Game, the processing of entries or prize claims, the announcement of the prizes, or in any Game-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by App users, tampering, hacking, or by any equipment or programming associated with or utilized in the Game. Released Parties are not responsible for injury or damage to participants' or to any other person's device related to or resulting from participating in this Game or downloading materials from or use of the App. Sponsor reserves the right to cancel or modify the Game if fraud, technical failures or any other factor impairs the integrity of the Game, as determined by Sponsor in its sole discretion. In such event, Sponsor reserves the right to award the prize at random from among all non-suspect, eligible entries received to the time of the impairment or as otherwise deemed fair and appropriate by Sponsor. Sponsor reserves the right in its sole discretion to disqualify any individual found to be tampering with the entry process or the operation of the Game or to be acting in violation of these Official Rules, or in an unsportsmanlike or disruptive manner and void all associated entries and/or prize claims. Any attempt by any person to deliberately damage or undermine the legitimate operation of the Game is a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserve the right to seek damages and other remedies (including, without limitation, attorneys' fees) from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. In the event of a dispute regarding entries received from multiple users having the same e-mail account, the authorized subscriber of the e-mail account at the time of entry will be deemed to be the entrant and must comply with these rules. Authorized account subscriber is the natural person who is assigned the e-mail address by the Internet Service Provider (ISP), on-line service provider, or other organization responsible for assigning e-mail addresses.
