**NO PURCHASE NECESSARY. A purchase will not increase the chance of winning.**

**Eligibility.** The Dream Weekend Sweepstakes 2 (the “Sweepstakes”) is open only to legal residents of the state of Nevada who are at least 18 years of age at the time of entry (the “Entrant”). The Sweepstakes is void elsewhere and where prohibited by law.
