

**“Your Wild Road Trip presented by Toyota”
Official Rules**

The Sweepstakes is void outside of the State of Minnesota and where prohibited or restricted by law. Employees, officers and directors of the Minnesota Wild Hockey Club, LP (“Wild” or “Sponsor”), Chicago Region Toyota Dealers Association, Inc. (“TDA”), Toyota Motor Sales U.S.A., Inc. - (2) **TO ENTER ON WILD.COM:** Entrants may visit <https://responses.wild.com/2526ToyotaYourWildRoadTripSweepstake> at any time during the Sweepstakes Period and enter to win by fully completing and submitting the provided form to receive one (1) entry. All eligible entries submitted during the Sweepstakes Period will be entered into a random drawing and eligible to win the prize (described in Section 6 below).
- (3) **TO ENTER VIA MAIL: LIMIT:** One (1) mail in entry per person and address (physical or email) in the Sweepstakes. All entries must be received by Wild during the Entry Period and become the exclusive property of the Wild. None will be acknowledged or returned. All entrants and entries are subject to verification prior to the awarding of a prize, as are the eligibility, age and other claims of/information provided by a potential prize winner. All entries may be sent via a self-addressed postage-stamped envelope to “Your Wild Road Trip presented by Toyota” Sweepstakes, Minnesota Wild, 317 Washington St., St. Paul, Minnesota 55102.

b. **COMPLIANCE WITH OFFICIAL RULES:** Failure to submit all required information in the manner required in these Official Rules may result in disqualification. Entries will not be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Wild. Any submission that does not comply with any aspect of these Official Rules may be rejected by the Wild and the entrant disqualified.

4. AGREEMENT TO OFFICIAL RULES AND DECISIONS. By participating in the Sweepstakes, each entrant fully and unconditionally agrees to be bound by and accepts these Official Rules and the decisions of the Wild (including, without limitation, decisions regarding eligibility of entries, the selection of entrants and the winners, and the awarding of prizes), which are final and binding in all respects.

6. PRIZE. Subject to the terms and conditions of these Official Rules, one (1) prize will be awarded to two (2) winners during this Sweepstakes. The prize will consist of and is limited to, one (1) trip for two (2) people to a Minnesota Wild away game during the 2025-2026 NHL Season. The prize will consist of flight, hotel, and game tickets. All costs for the flight, hotel, and game tickets will be paid for by the Wild. The approximate retail value ("ARV") of the prize is two thousand dollars ("\$2,000"). Prize must be accepted as awarded, and prize is awarded "AS IS" with no warranty, representation, or guarantee, express or implied, in fact or in law, made by Wild or for which Wild shall be liable, including, without limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE. No substitution, assignment, refund or transfer of a prize is permitted, except by the Wild, who reserves the right to substitute a prize (or a component thereof) with another prize (or component thereof) of greater or equal value, including cash, if a prize is not available for any reason as determined by the Wild in its sole discretion. Winner is solely responsible for any and all costs, fees, taxes and expenses associated with prize award, receipt and use, including, without limitation, all federal, state and local taxes associated with the prize and any travel required to collect the prize. If applicable, prize winner will be issued an IRS Form 1099 for the retail value of the prize. LIMIT: One (1) prize per person or address (physical or email) in this Sweepstakes.

7. PUBLICITY. Except where prohibited by law, participation in the Sweepstakes constitutes entrant's consent to the Wild's, TMS, TDA's (and their respective designees', successors' and assigns') use of entrant's name, biography, likeness, voice, photographs, video, opinions, statements, hometown, state and country for promotional purposes in any manner or media (including, without limitation, online), worldwide, in perpetuity, and without further payment, consideration, notice, review or consent.

8. GENERAL CONDITIONS. The Wild reserve the right, in their sole discretion, to terminate, modify or suspend the Sweepstakes if, in their opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, or if viruses, bugs, unauthorized intervention, fraud, technical difficulties or failures or any other factor beyond the Wild's reasonable control corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes. In such event, the Wild reserve the right (but do not have the obligation) in their sole discretion to award a prize at random from among eligible, non-suspect entries received up to the time of suspected impairment. The Wild reserve the right in their sole discretion to disqualify any individual they find to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately damage any website or undermine the legitimate operation of this Sweepstakes is a violation of criminal and civil laws, and, should such an attempt be made, the Wild reserve the right to seek damages and other remedies from any such person to the fullest extent permitted by law. The Released Parties are not responsible for: (a) incorrect or inaccurate transcription of entry information or late, lost, stolen, unintelligible, illegible, damaged, mutilated, altered, incomplete, misdirected or postage due entries or entries received through impermissible or illegitimate channels, all of which will be disqualified; (b) technical failures of any kind, including but not limited to the malfunctioning of any telephone, computer online systems, computer equipment, website, server provider, network, hardware or software; (c) the unavailability or inaccessibility of any website or service; (d) unauthorized intervention in any part of the entry process or the Sweepstakes; (e) printing, typographical, electronic or human errors which may occur in the offer or administration of the Sweepstakes or the processing of entries; or (f) any injury or damage to persons or property, including but not limited to entrant's computer, which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes, or from viewing, playing or downloading any material from the Wild's website(s), regardless of whether the material was prepared by the Wild or a third party, and regardless of whether the material is connected to the Wild's respective websites by a hypertext link.

Entrant may "opt-out" of receiving such marketing or promotional communications if entrant does not desire to receive such communications. Consenting to receive such emails and information (by "opting in") is optional, and is not necessary to enter or win this Sweepstakes, nor will it increase or improve entrant's chances of winning. By participating in the Sweepstakes, entrants consent to Wild's and TDA's collection, sharing, and use of their personal information and acknowledge that they have read and accepted the Privacy Policies.
