

**ANAHEIM DUCKS 2025-26 PLAYOFF TICKET ADDENDUM
PARTIAL SEASON TICKET HOLDER TERMS AND CONDITIONS**

By submitting payment for the 2025-26 playoff tickets (“Playoff Tickets”) referred to in the accompanying statement (the “Playoff Statement”) through the Anaheim Ducks’ online payment process, clicking “Submit Payment” or accepting delivery of the Playoff Tickets, the Partial Season Ticket Holder (“Holder”) agrees to be bound by the following terms and conditions (this “Addendum”) in connection with the purchase and use of the Playoff Tickets:

1. Playoff Tickets. A Playoff Ticket entitles Holder to admission to, if and as played, Anaheim Ducks home games at Honda Center (the “Arena”) during Rounds 1 through 4 of the 2025-26 NHL Stanley Cup Playoffs (i.e., Western Conference Quarterfinals, Western Conference Semi-Finals, Western Conference Finals, and Stanley Cup Final) (the “Playoffs”). Holder is not guaranteed the same seat location for the Playoff Tickets as Holder’s current partial season tickets. The seat location will be identified on each Playoff Ticket.

2. Incorporation of Existing Partial Season Terms. Except as expressly modified or supplemented herein, the terms and conditions of Holder’s existing 2025-26 Partial Season Ticket Agreement shall apply to the Playoff Tickets, including without limitation Sections 2 (Access to and Delivery of Tickets), 3 (Assignment and Resale), 6 (Notices), 7 (Lost or Stolen Tickets), 9 (Advertising and Promotions), 10 (Assumption of Risk), 11 (Personal Injury, Loss and Indemnification), 12 (Restrictions; Compliance with Laws, Rules and Regulations), 13 (Accessible Seating), 16 (Use of Images), 17 (Consent to Contact), 18 (Personal Information), 19 (Taxes), 20 (Modification), 21 (Waiver), 22 (Governing Law and Arbitration), 23 (Entire Agreement), and 24 (Section and Paragraph Headings).

3. Non-Refundable, Cancellation and Payment upon Breach. **PLAYOFF TICKETS ARE NON-REFUNDABLE, NON-RETURNABLE AND NON-EXCHANGEABLE.** Anaheim Ducks Hockey Club, LLC (“ADHC”) shall not be responsible to Holder for the cancellation or non-performance of any playoff game scheduled at the Arena or for the inability of Holder to use any of the Playoff Tickets due to any cause or circumstance beyond the control of ADHC, including without limitation strikes, lockouts, failure of utilities, restrictive laws or regulations and acts of God, pandemics, epidemics, acts of God, acts of war, or otherwise, including the residual effects of any of the foregoing after such event has ended (each, a “Force Majeure Event”), or for the inability of Holder to use any of the Playoff Tickets. Holder further acknowledges and agrees that (a) ADHC and/or the NHL may cancel, postpone, reschedule or relocate playoff games or events for any reason (including, without limitation, relocate an Anaheim Ducks playoff game from the Arena to an alternate venue in which case the Playoff Tickets shall not be applicable to such game) and modify or discontinue, temporarily or permanently, any aspect of the rules, operations and presentation of NHL playoff games and (b) ADHC has the right to terminate this Addendum or relocate the Playoff Tickets to an alternate seat location in the Arena in the event the original seat location(s), in ADHC’s sole discretion, are inoperable, unusable, no longer available to Holder or no longer offered for license to the public. The occurrence of any instances described in this Paragraph shall in no way be deemed, argued or construed to be a breach by ADHC of any terms, conditions, agreement or any other duties or obligations in connection with the sale and/or use of the Playoff Tickets or permit Holder to reduce, setoff or withhold payment for the Playoff Tickets or terminate this Addendum, and Holder hereby waives and releases any and all claims it may have against ADHC or the NHL with respect to such instances; provided, however, that if a paid-for Anaheim Ducks home playoff game at the Arena is cancelled due to a Force Majeure Event and not rescheduled or relocated to the Arena, ADHC shall refund to Holder with a pro-rata portion, as determined by ADHC in its reasonable business judgment, of the applicable prepaid ticket fees to reflect the loss of use of the affected Playoff Tickets for the remaining portion of the Playoffs. In the event this Addendum is cancelled or otherwise terminated as a result of Holder’s breach of this Addendum, Holder shall forfeit all monies paid to ADHC and Holder’s obligation to pay the outstanding balance, if any, of the total Playoff Ticket fees shall be accelerated making the full outstanding balance immediately due and payable to ADHC. This Paragraph shall survive the termination or expiration of this Addendum.

4. Excluded Events. Holder is not entitled to admission to any events that are not official 2025-26 Anaheim Ducks home playoff games played at the Arena.

5. Payment. The total fee for the Playoff Tickets, payment amounts, and due dates are shown on the Playoff Statement. To secure the seat location(s), Holder must make payment in full (or the first payment under any offered payment plan) by the due date shown on the Playoff Statement. If payments are not received by the specified due dates, ADHC may, in its sole discretion, disable barcodes on the Playoff Tickets (prohibiting access to the Arena), release the seat locations, and/or cancel the Playoff Tickets. A late fee of \$35.00 will be charged for any payments made after the specified due date. Holder’s cancellation, breach, or early termination of this Addendum does not relieve Holder from the obligation to pay all amounts shown on the Playoff Statement.

6. Entire Addendum. This Addendum, together with the Playoff Statement and the incorporated provisions of Holder’s existing Partial Season Ticket Agreement, contains the entire agreement between ADHC and Holder with respect to the Playoff Tickets and supersedes all prior understandings relating thereto. ADHC reserves the right at any time to modify, amend, or supplement the terms applicable to the Playoff Tickets.
