## Minnesota Wild "#mnwildfirst Sweepstakes" Official Rules

## NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

1. ELIGIBILITY. The Minnesota Wild "#mnwildfirst Sweepstakes" (the "Sweepstakes") is only open to entrants who, as of the entry date, are permanent legal residents of the United States who are at least eighteen (18) years old. The Sweepstakes is void outside of the United States and where prohibited or restricted by law. Additional entries beyond the specified limit, and any entries that do not comply with these Official Rules, will be void. Wild's computer shall be the official clock of the Sweepstakes.

The time of receipt of any valid Twitter entry shall be the time such valid entry becomes available to Wild on Twitter.com.

Comments and replies will not be judged, evaluated or otherwise used in any way to determine the winner. All entries must be received by Wild during the Entry Period and become the exclusive property of the Wild. On or about each necessary Minnesota Wild preseason, regular season and any potential playoff games ("Game"), the Wild, in its sole discretion, will select one (1) winner from all eligible entries received. Prize must be accepted as awarded, and prize is awarded "AS IS" with no warranty, representation, or guarantee, express or implied, in fact or in law, made by the Wild or for which the Wild shall be liable, including, without limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE. No substitution, assignment, refund or transfer of a prize is permitted, except by the Wild, who reserves the right to substitute a prize (or a component thereof) with another prize (or component thereof) of greater or equal value, including cash, if a prize is not available for any reason as determined by the Wild in its sole discretion. Winner is solely responsible for any and all costs, fees, taxes and expenses associated with prize award, receipt and use, including, without limitation, all federal, state and local taxes associated with the prize and any travel required to collect the prize. **7. PUBLICITY.** Except where prohibited by law, participation in the Sweepstakes constitutes entrant's consent to the Wild's (and their respective designees', successors' and assigns') use of entrant's name, biography, likeness, voice, photographs, video, opinions, statements, hometown, state and country for promotional purposes in any manner or media (including, without limitation, online), worldwide, in perpetuity, and without further payment, consideration, notice, review or consent.

8. GENERAL CONDITIONS.
