CONTEST RULES

"MINI GAME CAPTAINS PRESENTED BY IGA"

IMPORTANT: PLEASE READ THESE RULES (THE "RULES") CAREFULLY BEFORE ENTERING THE "MINI GAME CAPTAIN" CONTEST (THE "CONTEST") ORGANIZED BY CLUB DE HOCKEY CANADIEN, INC. (THE "ORGANIZER") IN COLLABORATION WITH IGA (THE "SPONSOR"). BY ENTERING THIS CONTEST, PARTICIPANTS CONFIRM THAT THEY MEET ALL ELIGIBILITY REQUIREMENTS SET OUT IN THE RULES AND AGREE TO COMPLY FULLY WITH THESE RULES AND TO ABIDE BY ALL DECISIONS OF THE ORGANIZER, WHICH ARE FINAL AND BINDING IN ALL RESPECTS RELATING TO THE CONTEST.

1. CONTEST PERIOD

1.1. The Contest begins on December 4th, 2025, at 12:00 a.m. (ET) and ends on December 24, 2025, at 11:59 p.m. (ET) (the "Contest Period"). The date and time of receipt of entries will determine their eligibility for the Contest.

2. ELIGIBILITY

2.1. The Contest is open kids between ages of 5 and 12 that knows how to skate. Notwithstanding the foregoing, the Contest is not open to employees, representatives, or agents of the Organizer, the Sponsor, their affiliates, subsidiaries, and related companies, their advertising and promotional agencies, their promotional partners, or suppliers of products or services related to the Contest, nor to persons domiciled with any of the foregoing (whether related or not), nor to members of their immediate families (father, mother, brother(s), sister(s), child(ren), and spouse, whether by marriage or common law).

3. HOW TO ENTER

3.1. NO PURCHASE NECESSARY TO ENTER OR WIN.

- 3.2. To enter the Contest, parents or legal guardians must, during the Contest Period, register by completing the entry form available on the Fan Club website at the following link: https://www.nhl.com/canadiens/fans/contests/mini-captains
 To be eligible to win a prize, all mandatory fields must be completed.
- 3.3. Limit of one (1) entry per person. This entry will remain valid for all games associated with this Contest.
- 3.4. No automated entry devices, robots, or other programs/software are permitted. The Organizer is not responsible for late, lost, misdirected, incomplete, or corrupted entries, which may be rejected and deemed ineligible.

4. PRIZES

- 4.1. There are a total of twenty-one (21) prizes available to be won (each, a "Prize"), consisting of:
- (i) Participation in the pre-game presentation and standing proudly with the team during the national anthem(s);
- (ii) Four (4) game tickets;
- (iii) One (1) Canadiens jersey with a captain's "C."
- 4.2. Actual Prizes may differ from those shown in Contest advertising and promotional materials, including but not limited to social media advertisements.
- 4.3. All costs and expenses not expressly stated as included in the Prize are the sole responsibility of the winner. This includes personal skates and protective equipment. However, a protective helmet, jersey, and hockey pants will be provided for the event but must be returned afterward. Winners are responsible for all applicable taxes and issuance fees not included in the Prize.
- 4.4. Prizes are non-transferable, non-exchangeable, non-substitutable, and have no cash value. The Prize must be accepted "AS IS," WITHOUT WARRANTY OF ANY KIND, either express or implied (including, without limitation, implied warranties of merchantability or fitness for a particular purpose). Substitution is permitted only at the sole discretion of the Organizer. If the Prize cannot be awarded as described, the Organizer reserves the right to substitute a Prize of equal or greater approximate retail value.
- 4.5. Under no circumstances will the Organizer, the Sponsor, their affiliates, subsidiaries, related companies, advertising and promotional agencies, promotional partners, suppliers, or their respective employees, officers, directors, agents, or

representatives be required to award more Prizes than set out herein or to award Prizes otherwise than in accordance with these Rules.

5. WINNER SELECTION

- 5.1. Winners will be selected by random draw conducted by the Organizer one (1) week prior to the game, at 10:00 a.m. (ET), at the Organizer's offices located at 1275 Saint-Antoine Street West, Montréal, Québec, H3C 5L2, from among all eligible entries received during the Contest Period.
- 5.2. Odds of winning depend on the number of eligible entries received.
- 5.3. Selected entrants will be contacted by phone or email using the contact information provided in their entry form. If a selected entrant cannot be reached within twenty-four (24) hours of the draw or if the Organizer determines, in its sole discretion, that the entrant does not meet all eligibility requirements, another draw will be conducted to select another potential winner. This process will continue until an eligible winner has been confirmed for each Prize.
- 5.4. The list of winners will be posted on the Contest website once identities are confirmed. Winners must consent to the public use of their name and city of residence on the Contest website. The Organizer is not responsible for delayed, lost, misdirected, or unsuccessful attempts to contact winners.
- 5.5. To be declared an official winner, each selected entrant must:
- (i) Comply with all instructions contained in the email sent by the Organizer confirming their selection; and
- (ii) Meet all Contest conditions as outlined in these Rules.
- 5.6. Failure to comply with any of the above or any other condition in these Rules will result in disqualification and selection of an alternate winner by random draw. This process will continue until the Prize is awarded.
- 5.7. Information provided by selected entrants upon contact by the Organizer must be complete and accurate.

6. PRIVACY

6.1. Personal information collected by the Organizer will be used solely for Contest administration. Additional informational or promotional communications from the Organizer and/or Sponsor may be sent to participants who provide consent by checking the appropriate box on the entry form. - 7.1. By entering or attempting to enter the Contest, participants release the Organizer, the Sponsor, the National Hockey League (NHL) and its member teams, the National Hockey League Players' Association (NHLPA), their affiliates, subsidiaries, related companies, advertising and promotional agencies, promotional partners, suppliers, and their respective employees, officers, directors, agents, and representatives (collectively, the "Released Parties") from any liability arising out of or related to the Contest, including without limitation, loss, damage, or injury of any kind associated with acceptance or use (or misuse) of a Prize, Contest administration, or winner selection.
- 7.2. Without limiting the generality of the foregoing, the Released Parties are not responsible for:
- (i) Any incorrect or inaccurate information, whether caused by site visitors, equipment, or programming associated with the Contest, or by human or technical error;
- (ii) Any error, omission, interruption, deletion, defect, or delay in Contest operations or transmission;
- (iii) Any communication line failure, theft, destruction, unauthorized access to, or alteration of entries;
- (iv) Any problems, malfunctions, or technical issues with computers, networks, servers, software, Internet congestion, or transmissions;
- (v) Any damage to third-party computers resulting from Contest participation or material downloads;
- (vi) Any injury, damage, or loss resulting from participation in the Contest or use of any Prize.
- 7.3. The Released Parties assume no responsibility if the Contest cannot proceed as planned due to causes including but not limited to computer virus, fraud, technical failure, or any other reason affecting the integrity or proper conduct of the Contest.

8. USE OF PERSONAL INFORMATION

8.1. By entering, participants consent to the Organizer's collection, use, and disclosure of their personal information for Contest administration, Prize fulfillment, and winner announcement. Participants further consent to the use, publication, and disclosure of their name, city of residence, photograph, image, voice, and statements, without compensation or notice, for advertising, marketing, or informational purposes in any media, worldwide, in perpetuity, in connection with this Contest or similar future contests, and agree to sign any necessary documentation.

9. GENERAL CONDITIONS

- 9.1. **Decisions:** All decisions of the Organizer and its representatives are final and binding.
- 9.2. **Property:** All entry forms, declarations, and related documents (collectively, "Entry Documents") become the property of the Organizer upon submission and will not be returned.
- 9.3. **Verification:** Entry Documents are subject to verification. Incomplete, illegible, fraudulent, late, or otherwise non-compliant entries will be void.
- 9.4. **Disqualification:** The Organizer reserves the right, in its sole discretion, to disqualify any entrant who fails to comply with these Rules or Fan Club terms, or who tampers with the entry process or makes false statements.
- 9.5. **Conduct:** Any attempt to deliberately damage any Contest-related element, including the Contest website, or to undermine Contest operations constitutes a violation of civil and criminal laws. The Organizer reserves the right to reject entries, report offenders to authorities, and seek damages to the full extent permitted by law.
- 9.6. **Participant Identification:** The Contest participant is the person named on the entry form. The Organizer may require ID before awarding a Prize.
- 9.7. **Website Functionality:** The Organizer makes no representation that the Contest site or related sites will operate uninterrupted or error-free during the Contest Period.

- 9.8. **Contest Modification:** The Organizer reserves the right to cancel, terminate, modify, or suspend the Contest in whole or in part at any time in the event of any issue affecting Contest integrity.
- 9.9. **Early Termination:** If the system is unable to record all entries during the Contest Period for any reason, the Organizer may, at its discretion, conduct draws from eligible entries received to that point.
- 9.10. **Communications:** No communication will be exchanged with participants except as provided in these Rules or as necessary for Contest administration, unless the participant has consented otherwise.
- 9.11. **Severability:** If any provision of these Rules is found unlawful or unenforceable, the remaining provisions will continue in effect.
- 9.12. **Language:** In the event of any discrepancy between the French and English versions of these Rules, the French version shall prevail.
- 9.13. **Gender:** The masculine is used for convenience only and includes all genders.
- 9.14. **Governing Law:** The Contest is governed by and shall be construed exclusively in accordance with the laws of the Province of Québec, without regard to conflict of laws provisions.
