

Official Rules for 2024 #LightningStrikes Playoffs Sweepstakes on X

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ENTRIES RECEIVED FOR THE APPLICABLE SWEEPSTAKES PERIOD. VOID WHERE PROHIBITED BY LAW. ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

The 2024 #LightningStrikes Playoffs Sweepstakes (the “**Sweepstakes**”) is sponsored by Tampa Bay Arena, LLC d/b/a Amalie Arena (“**Sponsor**”).

Sweepstakes is subject to these official rules (the “**Official Rules**”) and all federal, state and local laws, rules and regulations. Sponsor shall be entitled to interpret these Official Rules as needed – including but not limited to rules regarding deadlines, winner selection, prize restrictions, and eligibility – and all such decisions are final. By participating, you irrevocably, fully and unconditionally agree to be bound by these Official Rules and waive any right to claim ambiguity in these Official Rules and/or in any other Sweepstakes and/or Sweepstakes-related advertising or materials.

OVERVIEW: The Sweepstakes provides Tampa Bay Lightning (“**Lightning**”) fans the opportunity to answer which Lightning player will score the first goal during each Lightning game (each a “**Game**”) of the 2024 Stanley Cup playoffs (the “**Playoffs**”) prior to the Game in the Promotion Period (defined below). Fans will be given the opportunity to answer the question using the X platform (formerly known as “Twitter”). Fans who correctly answer the question will receive an entry for a chance to win the Prize announced.

ELIGIBILITY: To enter and be eligible to win, at the time of entry you must be a legal resident of the fifty (50) United States and the District of Columbia (excluding residents of Puerto Rico, the U.S. Virgin Islands and other U.S. territories and possession), be eighteen (18) years of age or older, have an X account (x.com), and not otherwise barred by law from participating in the Sweepstakes. Employees, officers, and directors (including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Sponsor and any other entity directly involved in the development or administration of the Sweepstakes, and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a Prize (defined below). The use of multiple identities is prohibited and will void each of that participant/person’s entries.

SWEEPSTAKES PERIOD: The Sweepstakes will begin on April 20, 2024, and will end on the date of the Stanley Cup Final, or the date of the last Lightning Game (whichever is sooner) (the “**Promotion Period**”). The Promotion Period will consist of a “**Sweepstakes Period**” per Game during the Playoffs. A Sweepstakes Period begins upon being announced by post via the @TBLightning X account (the “**Official X Account**”) (approximately one (1) hour before the scheduled puck drop time of the applicable Game as determined by the National Hockey League (the “**NHL**”) and ends when the first (1st) Lightning goal is scored. Sweepstakes Period start times may change subject to Game schedule and at Sponsor’s discretion, and all times are in Eastern Time (local to Tampa, FL). Submissions (defined below) received before or after a Sweepstakes Period will not be accepted or be eligible to win a Prize for that Sweepstakes Period. Sponsor’s computer is the official time-keeping device for the Sweepstakes.

HOW TO ENTER: Online entry only. No other method of entry will be accepted. During each Sweepstakes Period, follow the instructions provided by the Official X Account to receive one (1) “**Submission**” in the applicable Sweepstakes Period. If you correctly select the player who scores the first (1st) Lightning goal of the applicable Game during the Sweepstakes Period, you will receive one (1) entry into the drawing for that Sweepstakes Period (an “**Entry**”). Limit one (1) Submission **and** Entry per person per Sweepstakes Period. Additional entries beyond the specified limit will be void.

You must use your X account to enter. To participate in the Sweepstakes via X, you must have a valid, public (i.e., not “protected”) X account and follow the Official X Account. If you do not have an X account, visit www.x.com and register in accordance with the enrollment instructions for a free X account. Data and usage rates may apply to the download and use of the X application. All information submitted via X must

be submitted pursuant to and is subject to the (a) Content Restrictions (as set forth in the Content Restrictions section below), and (b) X's Terms of Service accessible at: <https://twitter.com/tos> and Privacy Policy accessible at: <https://twitter.com/privacy>. Further, all information submitted online via X and shared with, or otherwise made available to, Sponsor per your X account settings, or online directly to Sponsor in connection with the Prize Notification (defined below) process, will be subject to, and treated in a manner consistent with, Sponsor's Privacy Policy accessible at: <https://www.viniksportsgroup.com/privacy-policy/>. Failure to follow any instructions provided by the Official X Account, to submit your Submission within the applicable Sweepstakes Period or in compliance with the Content Restrictions, or to otherwise comply with these Official Rules may result in disqualification from the Sweepstakes. The time of receipt of any valid X Submission shall be the time such valid Submission becomes available to Sponsor on x.com.

RANDOM DRAWINGS: Following the end of the applicable Sweepstakes Period, but in no event later than twenty-four (24) hours, the potential winner of the applicable Sweepstakes Period will be selected by random drawing from all Entries received for that Sweepstakes Period. If there are no Entries for a Sweepstakes Period (in the event the Lightning are shutout or otherwise), no drawing will be held, and no Prize will be awarded. Subject to verification of eligibility and compliance with the terms of these Official Rules, the potential winner will be declared the official winner of the applicable Sweepstakes Period (each, a "**Winner**" and collectively, the "**Winners**"). The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of Entries received during the applicable Sweepstakes Period. **Limit one (1) Prize per person per Sweepstakes.** Any Submission you submit during a Sweepstakes Period after you are a Winner will be null and void. Submissions generated by a script, macro or other mechanical or automated means will be disqualified. In the event of dispute as to the identity or eligibility of any potential winner based on a X account, the winning Entry will be declared made by the Authorized X Account Holder of the X account used to enter the applicable Sweepstakes provided he/she is eligible according to these Official Rules. "**Authorized X Account Holder**" is defined as the natural person who is assigned to an X account by www.x.com.

PRIZES: Each Winner will receive one (1) 'Lightning Strikes' t-shirt (the "**Prize**"). Total Approximate Retail Value ("**ARV**") of each Prize is \$20. Prizes are non-transferable and non-assignable, with no cash redemptions except at Sponsor's sole and absolute discretion. Sponsor reserves the right to substitute any Prize (or any portion thereof) with a Prize of comparable or greater value at its sole and absolute discretion. Each Winner is fully responsible for any and all applicable federal, state and local taxes (including income and withholding taxes). If any Prize is mailed or shipped, Winner shall assume all risk of loss, damage, theft, late or missed delivery. If applicable, Sponsor, in its sole discretion, may permit a verified Winner to authorize, in writing, another adult to pick up his or her Prize; however, Winner must agree to release and hold Sponsor harmless from all liability for any Prize claimed by his or her authorized designee and Winner's designee will be required present photo ID. Upon fulfilling any Prize, Sponsor will be deemed to have awarded the Prize to the Winner and such Winner assumes full responsibility for the Prize.
