

2024-2025 30 DAYS OF COYOTES CLUB PRIZES SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE CHANCES OF WINNING. THE 2024-2025 30 DAYS OF COYOTES CLUB PRIZES SWEEPSTAKES (THE “SWEEPSTAKES”) IS INTENDED FOR PARTICIPATION ONLY IN THE STATE OF ARIZONA (THE “TERRITORY”) AND SHALL BE CONSTRUED ACCORDING TO AND GOVERNED EXCLUSIVELY BY ARIZONA STATE LAW. DO NOT PARTICIPATE IN THIS SWEEPSTAKES IF YOU ARE NOT A LEGAL RESIDENT WITHIN THE TERRITORY, PHYSICALLY LOCATED WITHIN THE TERRITORY AT THE TIME OF ENTRY, AT LEAST EIGHTEEN (18) YEARS OF AGE, OR DO NOT FALL WITHIN THE ELIGIBILITY REQUIREMENTS SET FORTH IN THESE OFFICIAL RULES. VOID WHERE PROHIBITED BY LAW.

1. **SWEEPSTAKES DESCRIPTION:** The Sweepstakes is administrated by IceArizona Hockey Co LLC d/b/a the Arizona Coyotes (the “Coyotes”). The Sweepstakes shall be conducted from 10:00 a.m. MST on Tuesday, January 16, 2024, until 9:00 a.m. MST on Thursday, February 15, 2024 (the “Sweepstakes Period”). One (1) daily winner will be randomly selected by Coyotes personnel from all eligible entries for a Prize. A random winner selection will be conducted daily for the length of the Promotion (each selection is a “Draw”). Winning a Draw will preclude an entrant from winning a subsequent Draw. Odds of winning depend on the actual number of eligible entries received. By participating in this Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these rules (the “Official Rules”) and the Coyotes’ decisions regarding the Sweepstakes, which shall be final and binding.

2. **WHO MAY ENTER:** This Sweepstakes is open only to legal residents of the state of Arizona who are eighteen (18) years of age or older at the time of entry and physically located within the state of Arizona at the time of entry. Employees, agents, officers, directors, members, managers, and owners of the Coyotes, IceArizona Holdings LLC, IceArizona AHL Co LLC, the Arizona Coyotes Foundation, the National Hockey League (the “NHL”) and its member clubs, and each of their respective parents, subsidiaries, affiliates, owners, members, directors, managers, officers, employees and their advertising agencies, promotional partners and prize providers associated with this Sweepstakes (each a “Promotion Entity” and collectively the “Promotion Entities”), and their immediate family members (spouses, domestic partners, parents, legal guardians, grandparents, grandchildren, siblings, children and “step” of each) and those individuals living in their same household are not eligible to enter or win. A potential prizewinner of the Sweepstakes may be required to show proof of residency and other documents to confirm eligibility.

3. **WHEN TO ENTER:** The Sweepstakes shall be open from 10:00 a.m. MST on Tuesday, January 16, 2024, until 9:00 a.m. MST on Thursday, February 15, 2024. Entries received during the Sweepstakes Period shall be an eligible entry for purposes of a prize drawing. The Coyotes’ database clock shall be the official time keeping device for all entries received in connection with this Sweepstakes.

4. **HOW TO ENTER: To enter the Sweepstakes, a potential entrant must do one of the following:**

- Renew or Purchase 2024-25 Arizona Coyotes Season Tickets. On the date of becoming a 2024-25 Season Ticket Member, ticket purchaser will earn one (1) entry per account in the Sweepstakes. Renewal/purchase must be completed via the online Arizona Coyotes Account Manager, faxing, or mailing in renewal documentation, or in person. The date of renewal or purchase for purposes of entry into the Sweepstakes will be the date the first payment (1/11 of the season ticket package price) is received by the Coyotes. On each day of the Sweepstakes Period following the date of renewal or purchase, ticket purchaser will earn one (1) entry each day for the remainder of the Draws during the Sweepstakes Period; OR

EACH ENTRANT’S ENTRY CONSTITUTES THE ENTRANT’S IRREVOCABLE, SUB-LICENSABLE, ABSOLUTE RIGHT AND PERMISSION FOR THE COYOTES TO USE, PUBLISH, POST, OR DISPLAY THE ENTRANT’S NAME, IMAGE, AND LIKENESS, AND ANY VARIATIONS THEREOF IN ANY FORM WITHOUT FURTHER AUTHORIZATION OR ANY COMPENSATION.

Proof of entry is not considered proof of delivery to or receipt by the Coyotes of entry into the Sweepstakes. In the event of a dispute regarding the identity of who submitted an entry, the entry will be deemed submitted by the authorized account holder of the email address supplied at the time of entry. An “authorized account holder” is defined as the natural person to whom the applicable email address has been assigned by the internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the address submitted. A potential prizewinner may be required to provide proof that they are the authorized account holder of the email address associated with the winning entry.

5. **DRAWINGS AND PRIZEWINNER NOTIFICATION:** Potential prizewinners will be selected in a random prize drawing via online number generator from eligible entrants. One (1) daily winner will be randomly selected by Coyotes personnel from all eligible entries for a Prize. A random winner selection will be conducted daily for the length of the Promotion (each selection is a "Draw"). Winning a Draw will preclude you from winning a subsequent Draw.

Determination of the prizewinner shall be made by the Coyotes or its agents in their sole and absolute discretion and such determination shall be final and binding. The potential prizewinner will be notified using the contact information email provided at the time of entry. The Coyotes shall have no liability for any prizewinner notification that is lost, intercepted, or not received by a potential prizewinner for any reason. If the selected prizewinner cannot be reached by email or does not promptly respond to the potential prizewinner notification as determined in the Coyotes' discretion, the Prize may be forfeited, and an alternate prizewinner may be selected in another online number generator random drawing from the remaining eligible entries. The Coyotes will attempt to contact the potential prizewinner in accordance with the aforementioned procedure, after which the Prize may go unawarded if it remains unclaimed by an alternate prizewinner. If the potential prizewinner is determined to be ineligible or declines the Prize for any reason prior to award, such potential prizewinner will be disqualified, forfeit any claim to the Prize, and an alternate prizewinner may be selected in another online number generator random drawing from the remaining eligible entries.

6. **PRIZE/ODDS:** One (1) Prize is available per day of the Promotion. The Prize schedule and approximate retail values of each daily Prize are detailed in "Appendix A" to these Official Rules. Odds depend on the number of entries.

7. **GENERAL PRIZE RESTRICTIONS:** All other expenses not specified herein as part of a Prize shall be the sole responsibility of the prizewinner including, without limitation, delivery, processing, and handling. No cash alternative or prize substitutions will be allowed, except that the Coyotes reserve the right to substitute a prize of comparable value if the prize listed is unavailable for any reason. A Prize is non-assignable and nontransferable. If lost, a Prize awarded herein will not be replaced. A Prize will not be substituted, except at the Coyotes' discretion, except where prohibited by law. Prizewinners are solely responsible for the reporting and payment of any federal, state and/or local taxes on any Prize. All details and other restrictions of the Prize not specified in these Official Rules will be determined by the Coyotes in its sole and absolute discretion.

The Coyotes and/or its respective related entities and agents are not responsible for fraudulent communications including without limitation phone calls or emails made by or sent to entrants. By entering the Sweepstakes, each entrant hereby: (a) agrees that the Promotion Entities will have no liability whatsoever for, and shall be held harmless by participants against, any liability for any injuries, losses, or damages of any kind to person(s), including without limitation death, or property resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of the Prize or participation in this Sweepstakes or any Sweepstakes-related activity, or for any typographical or other error in the printing, offering or announcement of the Prize; (b) releases the Promotion Entities from all liability, claims, action, or proceedings relating to this Sweepstakes and from injuries, death, or damages arising in connection with or relating to participation in this Sweepstakes, or use or misuse of the Prize; and (c) waives any right to claim ambiguity in the Sweepstakes or these Official Rules. The Coyotes reserve the right to modify these Official Rules for clarification purposes without materially affecting the terms and conditions of the Sweepstakes, to void suspect entries and/or cancel, terminate, or suspend any portion of this Sweepstakes. This Sweepstakes may not be used for any form of gambling.

10. **IMPORTANT: PLEASE READ - GENERAL RELEASE AND LIMITATIONS ON LIABILITY.** By entering the Sweepstakes, each entrant agrees that: (1) any and all disputes, claims, and causes of action arising out of or connected with the Sweepstakes, or the Prize awarded, shall be resolved individually, without resort to any form of class action; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes, but in no event will attorneys' fees be awarded or recoverable; and (3) under no circumstances will any entrant be permitted to obtain any award for, and entrant hereby knowingly and expressly waives all rights to seek, punitive, incidental, or consequential damages and/or any other damages, other than actual out-of-pocket expenses, and/or any and all rights to have damages multiplied or otherwise increased. Each entrant acknowledges and agrees that the Promotion Entities are not responsible for any costs, injuries, losses, or damages of any kind arising from or in connection with: (i) incomplete, lost, late, misdirected, or illegible entries or for failure to receive entries due to any cause, including without limitation human, transmission, or technical problems, failures, or malfunctions of any kind, whether originating with sender, with the Coyotes, or otherwise, that may limit an entrant's ability to participate in the Sweepstakes; (ii) incorrect or inaccurate information whether caused by internet users, or by any equipment or programming associated with or utilized in connection with this Sweepstakes and assume no responsibility for any error, omission, malfunction, interruption, deletion, defect, or delay in operation or transmission, communications line failure, theft, or destruction or unauthorized access to, tampering, or hacking; (iii) any injury or damage resulting from participation in the Sweepstakes and/or the use and/or misuse of any Prize (including, without limitation, claims, costs, injuries, losses and damages related to personal injuries, death, damage to, loss or destruction of property, or any claims, costs, injuries, losses, or damages related to or based on the entrant's rights of publicity or privacy); or (iv) the entrant's claim that he or she has somehow been defamed or portrayed in a false light. Promotion Entities assume no responsibility for any errors or failures, delayed computer transmissions or network connections that are human or technical in nature, or for the incorrect or inaccurate capture of information, or the failure to capture any information. In the event the Coyotes are prevented from awarding a Prize or continuing with the Sweepstakes as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis (e.g., COVID-19), order of any court or jurisdiction, or other cause not reasonably within the Coyotes' control (each a "**Force Majeure**" event or occurrence), then subject to any governmental approval which may be required, the Coyotes shall have the right to modify, suspend, or terminate the Sweepstakes. If the Sweepstakes is terminated before the designated end date, the Coyotes will (if possible) select prizewinners in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. These Official Rules cannot be modified or amended in any way except in a written document issued by a duly authorized Coyotes representative. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. 11. **GOVERNING LAW AND DISPUTE RESOLUTION:** AS A CONDITION OF ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES THAT ANY AND ALL DISPUTES, CLAIMS, CONTROVERSIES, OR CAUSES OF ACTION ARISING OUT OF OR RELATING TO THE SWEEPSTAKES OR THE PRIZE AWARDED (EACH, A "CLAIM") SHALL BE (I) ARBITRATED ON AN INDIVIDUAL BASIS ONLY, AND SHALL NOT BE CONSOLIDATED OR JOINED WITH OR IN ANY ARBITRATION OR OTHER PROCEEDING INVOLVING A CLAIM OF ANY OTHER PARTY, AND (II) SETTLED BY BINDING ARBITRATION IN MARICOPA COUNTY, ARIZONA BEFORE A SINGLE ARBITRATOR APPOINTED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS THEN GOVERNING RULES AND

PROCEDURES, AND JUDGMENT ON THE AWARD RENDERED BY THE ARBITRATOR MAY BE ENTERED BY ANY COURT HAVING JURISDICTION THEREOF.
