## NY RANGERS "FAN FIRST" SWEEPSTAKES (the "Sweepstakes")

## **OFFICIAL RULES**

## NO PURCHASE NECESSARY. VOID WHERE PROHIBITED. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

- 1. PERIOD: Sweepstakes begins at 11:00 a.m. Eastern Time ("ET") on October 7, 2025 and ends at 11:59 p.m. ET on October 14, 2025 (the "Sweepstakes Period").
- 2. ELIGIBILITY: Sweepstakes is open to legal U.S. residents of New York, New Jersey and Connecticut, at least eighteen (18) years old at time of entry and who reside within a 75-mile radius of the arena at Madison Square Garden. Sweepstakes is void outside the area stated herein and where prohibited by law. Multiple entries from any person will be void. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. All entries become the property of Sponsor and will not be acknowledged or returned.

4. SELECTION OF WINNER: Sponsor will randomly select one (1) potential winner after the Sweepstakes Period from among all eligible entries ("Potential Winner"). Potential Winner will be notified by mobile phone or email (depending on method of entry). Potential Winner must comply with all terms and conditions of these Official Rules, and winning a prize is contingent upon fulfilling all requirements. Potential Winner (or the parent or legal guardian of such Potential Winner if applicable) may be required to sign and return an Affidavit of Eligibility, W-9 Form and Liability/Publicity Release within twenty-four (24) hours of the date of notice in order to claim his/her/their prize and become an official winner ("Official Winner").
