

OFFICIAL RULES

DALLAS STARS CHOCTAW PLAYOFF SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. VOID WHERE PROHIBITED. MUST BE 18 YEARS OF AGE OR OLDER TO ENTER.

ELIGIBILITY: The Dallas Stars Choctaw Playoff Sweepstakes (the “Sweepstakes”) is only open to persons who satisfy all of the following requirements at the time of entry: (i) are legal residents of the United States; (ii) reside in Texas; (iii) are at least eighteen (18) years of age; and (iv) are not otherwise ineligible to enter the Sweepstakes. Employees and immediate families of employees (spouse, parents, siblings and children, regardless of where they live), and anyone living in the same household as such employees, of The Choctaw Nation of Oklahoma (the “Sponsor”), DSE Hockey Club, L.P. (the “Administrator” or “Co-Sponsor”), DSE Hockey Club, GP, Inc., Center Operating Company, L.P., Dallas Sports & Entertainment, L.P., the National Hockey League and its member clubs, NHL Enterprises, L.P. the NHL Enterprises Canada, L.P., NHL Enterprises, B.V., NHL Interactive Cyber Enterprises, LLC and each of their respective parents, subsidiaries, affiliates, and related entities, and each of the aforementioned parties’ respective directors, officers, owners, members, employees, agents, and suppliers, agencies are not eligible to participate in or win the Sweepstakes. The Sponsor and Administrator are collectively referred to as the “Sweepstakes Entities”. Sweepstakes is subject to all applicable federal, state, local laws and regulations and is void where prohibited by law. HOW TO ENTER: To enter, during the Sweepstakes Period visit www.DallasStars.com/Choctaw (“Website”) and follow the online instructions to submit an entry. Limit of one (1) entry per person, regardless of method of entry. Duplicate entries for a single individual will be disqualified. All entries become the property of the Sweepstakes Entities.

PRIZE AND ODDS OF WINNING: One (1) potential prize winner will be selected in a random drawing on or about May 6, 2024 from all eligible entries received during the Sweepstakes Period (the “Winner”). The Winner will receive:

- either: (a) four (4) tickets to a Dallas Stars home game during Round 2 of the 2023-24 NHL Playoffs at the American Airlines Center in Dallas, Texas (if the Dallas Stars win Round 1 of the NHL Playoffs and advance to Round 2 of the NHL Playoffs) or, (b) if the Dallas Stars do not advance to Round 2 of the NHL Playoffs, four (4) tickets to a 2024-25 NHL Regular Season Dallas Stars Home Game (game awarded to be determined by Sweepstakes Entities in their sole discretion) (\$250/ticket value; \$1000 total value),
- one (1) Dallas Stars jersey signed by a member of the 2023-24 Dallas Stars NHL team (player jersey awarded to be awarded by Sweepstakes Entities in their sole discretion) (\$210 value), and

- a two (2) night “VIP Stay” (one (1) standard room/double occupancy) at Choctaw Casino & Resort Durant in Durant, Oklahoma (the “Resort”), on dates selected by Winner, subject to availability and approval by Sponsor, which includes a credit for dinner at 1832 Steakhouse at the Resort (up to \$350, alcohol not included), a spa credit for spa services at the Resort (up to \$250), and two (2) tickets to a concert at Grand Theater at the Resort (subject to availability).
