FLAT BLADES HOLIDAY CHALLENGE

OFFICIAL CONTEST RULES

- 1. <u>Sponsor and Administrator</u>: Flat Blades Holiday Challenge ("Contest") is sponsored and administered by Boston Professional Hockey Association, Inc. ("Sponsor").

All times in this Contest refer to Eastern Daylight Time. By participating, Entrants agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are at its sole discretion and are binding and final.
