

### **Stadium Series Sweepstakes**

The following terms and conditions (collectively, the "Official Rules") shall apply to the Stadium Series Sweepstakes (the "Sweepstakes").

**Eligibility: VOID WHERE PROHIBITED.** The Sweepstakes is open to legal residents of the United States (excluding residents of Puerto Rico, U.S. Virgin Islands, Guam and other United States territories) who are at least 18 years of age at the time of entry. All eligibility is further subject to all federal, state, and local laws and regulations. All entries submitted are the property of New York Islanders Hockey Club, L.P. (the "Sponsor"). No purchase necessary to enter or win the Sweepstakes. A purchase will not increase or impact your chances of winning. During the Sweepstakes Period, you may enter the Sweepstakes by visiting [newyorkislanders.com/series](https://newyorkislanders.com/series) and completing an online entry form. Only one (1) entry per person is permitted during the Sweepstakes Period.

By submitting any entry, you agree to be bound by these Official Rules. Entries that do not comply with these Official Rules will be disqualified.

Three (3) winners (each, a "Winner"; collectively, the "Winners") will be selected in a random drawing containing all eligible entries received during the Sweepstakes Period. The drawing will take place on February 12, 2024. Sponsor's decision is based on its sole discretion and interpretation of these Official Rules and is final and binding in all respects. The first Winner selected will receive two (2) tickets (i.e., one (1) ticket for Winner and one (1) ticket for Winner's guest), with the exact seating location to be determined by Sponsor in its sole discretion, to the New York Islanders Stadium Series game on February 18, 2024 and one (1) Stadium Series jersey (the "Grand Prize"). The second Winner selected will receive one (1) Stadium Series shirt and one (1) Stadium Series hat (the "Second Prize"). The third Winner selected will receive one (1) Stadium Series hat, one (1) Stadium Series puck, and one (1) Stadium Series key chain (the "Third Prize"). Each of the Grand Prize, the Second Prize, and the Third Prize shall be referred to herein as a "Prize" and collectively as the "Prizes". The approximate retail value ("ARV") of the Grand Prize is \$555.00. The ARV of the Second Prize is \$70.00. The ARV of the Third Prize is \$74.00. ARV of all Prizes, collectively: \$699.00. If a Winner is unreachable by February 14, 2024 at 5:00 p.m. ET, or if a Winner is unavailable for a Prize, an alternate Winner may be selected by the Sponsor. The Prizes are nontransferable.

By claiming a Prize, each Winner authorizes the use, without additional compensation, of Winner's name and/or likeness and/or voice/photograph and/or municipality of residence for promotion and/or advertising purposes in any manner and in any medium which the Sponsor may deem appropriate.
