

**Fanatics Fest Sweepstakes

**OFFICIAL RULES**

**NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.  
A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

1. **SWEEPSTAKES PERIOD:** Fanatics Fest Sweepstakes presented by Infosys (the “Sweepstakes”) begins at 9:00 a.m. Eastern Time (“ET”) on July 7, 2026 and ends at 11:59 p.m. ET on July 14, 2026 (“Sweepstakes Period”).

2. **ELIGIBILITY:** OPEN ONLY TO LEGAL U.S. RESIDENTS OF NEW YORK, NEW JERSEY AND CONNECTICUT WHO RESIDE WITHIN A 75-MILE RADIUS OF MADISON SQUARE GARDEN (THE “ARENA”) AND ARE AT LEAST 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. VOID OUTSIDE THE AREA STATED HEREIN AND WHERE PROHIBITED. Limit one (1) entry per person. Multiple entries from any person or email address will be void. Entries generated by artificial intelligence, script, macro, automated, or by any means which subvert the entry process are void. All entries become the property of Sponsor and will not be acknowledged or returned.

4. **SELECTION OF WINNERS:** One (1) potential winner will be selected at random on or about July 15, 2026 from among all eligible entries received during the Sweepstakes Period and notified by phone and/or email by Sponsor. Potential winner must comply with all terms and conditions of these Official Rules, and winning a prize is contingent upon fulfilling all requirements. Potential winner may be required to sign and return an Affidavit/Declaration of Eligibility and/or Liability/Publicity Release within such time period specified in the prize notification in order to claim the prize and become an official winner (“Official Winner”). If a

prize notification is returned as undeliverable; or the potential winner cannot be contacted or does not respond to the prize notification within the specified time period; or fails to sign and return the Affidavit/Declaration of Eligibility and Liability/Publicity Release within the specified time period; or is not in compliance with these Official Rules, such potential winner may be disqualified and in such event will forfeit the prize. Travel is not included as part of the prize. Attendance at the Event during all 4 days is not required. The prize is awarded "as is" with no warranty or guarantee, either express or implied. Sponsor will not replace any lost, mutilated, or stolen tickets. If the Event is delayed, postponed, or cancelled for any reason, the terms of the tickets shall govern.
