Should the Boston Bruins' compete in the 2026 postseason schedule, Sweepstakes will run until the Boston Bruins are no longer active in the NHL postseason (collectively the "Sweepstakes Period"). A random drawing will be held by Sponsor one week before each Boston Bruins' home game. The odds of winning a prize depend on the total number of eligible entries received during the Sweepstakes Period (each an "Entry"). Sponsor cannot accurately predict the number of entrants who will participate in the Sweepstakes (each an "Entrant"). All times in this Sweepstakes refer to Eastern Time. By participating, Entrants agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are at its sole discretion and are binding and final. The Sponsor's decisions are final, binding and conclusive on all matters related to the Sweepstakes. Sponsor reserves the right to require the winner to sign and return to the Sponsor an affidavit of eligibility upon accepting the prize. If the winner is not responsive within twenty-four (24) hours of initial notification or in the event of non-compliance with any of these requirements, the prize will be forfeited, and an alternative winner will be chosen. Up to two alternative winners will be selected per game. Once a winner is selected and has accepted a prize the winner is no longer eligible to win another prize during the Sweepstakes Period.

The prize will consist of four (4) tickets to a Bruins' home game. Winners will also be shown on Hub Vision (Jumbotron) during the prize game, highlighting that they were that game's winner. In the event the game is cancelled or postponed for any reason, Sponsor reserves the right to substitute or award an alternative prize of approximate value with no further obligation to the winner. The estimated value of the prize is \$115 per ticket, (\$460 total). The prizes cannot be exchanged for cash and there are no date or seat substitutions.
