1. **Sponsor and Administrator:** TD FANSGIVING 2026 SWEEPSTAKES (“Sweepstakes”) is administered by Boston Professional Hockey Association, Inc. (“Administrator”). Prizes for this Sweepstakes are presented by TD Bank, N.A.
 2. **General:** By participating in this Sweepstakes, the participant acknowledges and agrees to all these Official Rules. Void where prohibited. Sweepstakes begins on Tuesday, April 7th 2026, and runs until Tuesday, April 14th, 2026 (collectively the “Sweepstakes Period”). The odds of winning a prize depend on the total number of eligible entries received during the Sweepstakes Period (each an “Entry”). Administrator cannot accurately predict the number of entrants who will participate in the Sweepstakes (each an “Entrant”). All times in this Sweepstakes refer to Eastern Time. Entrants will be eligible to win the prize posted the day that their Entry is made and for all subsequent prizes after their Entry is made. Limit one (1) prize per Entrant during the Sweepstakes Period. If an Entrant is chosen as a winner during the Sweepstakes Period they are no longer eligible to win subsequent prizes.
