SCHEDULE "B"

RAFFLE RULES

- 1. Foundation:** The Raffle (the "Raffle") shall be conducted by the Edmonton Oilers Community Foundation (the "Foundation") pursuant to a Raffle license (the "AGLC Raffle License") from the Alberta Gaming, Liquor and Cannabis Commission ("AGLC") and in accordance with the Criminal Code of Canada, Alberta Gaming and Liquor Act and Regulations, AGLC Policy, AGLC Raffle Terms and Conditions, and the terms of the Raffle Services Agreement between the Foundation and Win 50 Ltd. (the "Service Provider").
- 2. Date and Location of Draw:** The draw will take place by random number generation ("RNG") on June 22, 2026, and is open to the public. The draw will take place at the Foundation's Offices (300-10214 104 Ave NW).
- 3. Rules:** These are the official Raffle Rules and are available upon request.
- 4. Eligibility:** The Raffle is open to all persons who are located in the Province of Alberta when purchasing tickets online. Ticket purchasers must be 18 years of age or older. Employees of the Service Provider, the Foundation including its Board of Directors and Officers, Edmonton Oilers Hockey Corp., Oilers Entertainment Group Canada Corp., Oilers Entertainment Group Services Ltd. and members of their immediate family (defined as mother, father, brother, sister, son, daughter, husband or wife, who reside in the same household) are NOT eligible to participate (defined as purchase tickets or receive prizes) in the Raffle. In addition, employees and board members of the beneficiary for that Raffle will NOT be eligible to participate in the Raffle. Each ticket sold shall be eligible to participate in each draw conducted under the authority of the AGLC Raffle License.
- 5. Minor Children:** Adult ticket purchasers are not to give their ticket to a person under the age of 18 years. If it is determined prior to the draw that a ticket has been issued to a person under the age of 18 years, the ticket is deemed void and the purchaser refunded. If a person under the age of 18 years does win a Prize then the purchaser will be refunded and the ticket is deemed void and a re-draw will be conducted.
- 6. No Transfer of Tickets:** Ticket Purchasers may not transfer their tickets to anyone else prior to claiming the prize.
- 7. Tickets:** Ticket pricing shall be:

Regular Ticket:	\$25.00 purchase: the number will be entered into the draw 1 time
Discount 1 Ticket:	\$49.00 purchase: the number will be entered into the draw 5 times
Discount 2 Ticket:	\$99.00 purchase: the number will be entered into the draw 15 times (each a "Chance to Win Number")

There are 3,200,000 raffle ticket numbers available on the AGLC Raffle License.

- 8. No Refunds.** All ticket sales are final. There will be no refunds issued to anyone for any reason. All tickets purchased and for which the raffle ticket numbers on those respective tickets are entered into the draw cannot be refunded, including if a ticket purchaser made an error in selecting the amount of tickets they desire to purchase.
- 9. How to Purchase Online:** Visit www.edmontonoilers.com/picktowin during the Raffle and follow the directions to purchase and print the tickets for the Raffle.

Ticket Purchasers purchasing Raffle tickets online must fully complete their purchase using the procedures specified above. All online purchases are subject to and will be treated in a manner consistent with the website terms of use and privacy policy.

Upon purchasing Tickets, Ticket purchasers will be given the option to select how many chances will be allocated to which specific Raffle Item for the Raffle. If Ticket purchasers do not select how many chances will be allocated to which

specific Raffle Item for the Raffle prior to clicking the “confirm” button, Tickets will be automatically allocated equally among the Raffle Items, with any excess chances being automatically allocated to Raffle Item(s) selected by the Raffle system. Chance allocation will be final and cannot be adjusted once the Ticket purchaser has made their allocation and clicked the “confirm” button.

Each Chance to Win will bear a unique identification number ("Chance Number" or "Chance to Win Number") and those Chance to Win Numbers shall be used to determine the winner of the Draw. Multiple Chance to Win Numbers obtained in a single transaction will be consolidated into a single receipt at the time acquired. Chance to Win Numbers are only for this specific Draw and not for future Draws.

All methods of purchase may not be available at all times. If the System experiences any technical difficulties during an event or in the event virus, bugs, unauthorized human intervention, power failure or other causes corrupt administration, security, fairness, integrity or proper operation of the Raffle (or any portion thereof), the Foundation reserves the right in its sole discretion to: (i) cancel the Raffle; or (ii) suspend the Raffle until the problem can be remedied, whereupon it will resume. Without limiting the generality of the foregoing, in the event of a cancellation or suspension, the Foundation reserves the right, in its sole and absolute discretion, to elect to identify a winner and award the prize by way of random drawing from among all non-suspect, eligible entries received up to the time of such cancellation or suspension.

- 10. The Draw:** Tickets will be available for purchase starting at 9:00 AM MST on April 7, 2026. Sales will close at 11:59 AM MST on June 22, 2026. After Sales have been closed, the draw shall take place and be announced no later than 11:59 PM on June 22, 2026. The draw shall take place at the Foundation’s Offices (300-10214 104 Ave NW), and will be open to the public. The winning raffle ticket number will be selected via RNG.

Only chances allocated for a specific Raffle Item will be entered into the draw for that Raffle Item.

- 11. Winner Notification:** The winning raffle ticket numbers will be posted on the Foundation website at www.edmontonoilers.com/picktowin shortly after the draw. In the case of a discrepancy between the posted raffle ticket number and the actual raffle ticket number selected through RNG, the actual raffle ticket number selected through RNG will be considered to be the valid winning raffle ticket number.

The holder of the ticket containing the winning raffle ticket number for the Raffle will have until 4:00 PM MST 90 days from the time of the announcement of the winning raffle ticket numbers for the Raffle to present the ticket containing the winning raffle ticket number to the Foundation. If the winner has not come forward within 60 days from the time of the announcement of the winning jackpot raffle ticket number for the Raffle, the Foundation will use the email and/or phone number if provided by the ticket purchaser to try to contact them.

Ticket purchasers may not transfer their tickets to anyone else prior to claiming the prize. The holder of the ticket containing the winning raffle ticket number may claim their prize by contacting the Foundation office at picktowin@edmontonoilers.com and forwarding their purchase e-mail and a copy of their government issued photo identification and address or present their purchased ticket to the Foundation. The name on the government issued photo identification must match the name that was used to purchase the ticket. If more than 1 name is written on the ticket, the Prize will be awarded to only 1 of the individuals named on the ticket, and none of the Foundation, the Service Provider or the AGLC are responsible for any disputes among the individuals whose names are on the ticket. Each prize claimant must provide the Foundation with all information required by provincial gaming regulations to claim a prize. The prize claimant will be required to sign a Declaration and Release ("Release") which must be executed and returned to the Foundation no later than 5 business days after his/her receipt of the Release. The winner’s name, image, city or town of residence and statements will be publicized on the list of prize winners located at www.edmontonoilers.com/picktowin and will be used for the purposes of advertising, publicity and promotion in any matter or media as the Foundation may determine, without further compensation to the winner other than the prize awarded. All prizes will be awarded to the winners within 60 days of the winner delivering the ticket containing the winning raffle ticket number, the executed Release, and all other required documents to the Foundation. Prizes not

claimed on or before the Prize Claim Expiry Date (4:00 PM MST, 90 days from the time of the announcement of the winning jackpot raffle ticket number for the Raffle), will be be donated to a charitable beneficiary approved by AGLC.

12. The Prize: Prizes are as outlined on Foundation website at www.edmontonoilers.com/picktowin.

In the Raffle:

- (a) 30% of the gross revenue received from all tickets sold will be allocated to a progressive cash prize #1 (the "Progressive Cash Prize #1"). The Foundation will start the jackpot of the Progressive Cash Prize #1 at \$1,000.00. The Progressive Cash Prize #1 will be 30% of \$1,000.00 plus 30% of the gross revenue received from all tickets sold for the Raffle;
- (b) 15% of the gross revenue received from all tickets sold will be allocated to a progressive cash prize #2 (the "Progressive Cash Prize #2"). The Progressive Cash Prize #2 will be 15% of the gross revenue received from all tickets sold for the Raffle;
- (c) 5% of the gross revenue received from all tickets sold will be allocated to a progressive cash prize #3 (the "Progressive Cash Prize #3"). The Progressive Cash Prize #3 will be 5% of the gross revenue received from all tickets sold for the Raffle;
- (d) 1 prize will be a 12-seat suite to 1 Edmonton Oilers regular season home game in the 2026-27 season, as determined by the Foundation in its sole discretion, which will include \$1,000.00 credit for food and beverage to be used at the game (the "Oilers Suite Prize"). Retail value of the Oilers Suite Prize is approximately \$14,000.00. For clarity, no refund will be given if the food and beverage credit is not used up in its entirety at the game; and
- (e) 1 prize will be 1 Edmonton Oilers jersey signed by 1 Edmonton Oilers player as determined by the Sponsor in its sole discretion (the "Oilers Jersey Prize"). Retail value of the Oilers Jersey Prize is approximately \$500.00.

Prizes are not transferable and must be accepted as awarded with no substitutions, except at the Foundation's sole discretion. The Progressive Cash Prizes shall be paid by cheque from the Foundation. The designated winning raffle ticket number contained in the ticket purchaser's ticket is validation for claiming the Prize.

Unauthorized persons copying, selling or altering tickets are subject to prosecution. A Raffle ticket will be void and a Prize not paid/redeemed if there is proof that the ticket was stolen, not issued, ineligible, altered, counterfeit, defective, printed in duplicate, or printed/produced in error. The Service Provider and the Foundation are not responsible for lost or stolen tickets or tickets redeemed in error by their agents. All tickets, transactions and winners associated with the Raffle are subject to the rules, regulations and procedures put in place by the Foundation and the lawful charges thereof.

13. Release of Liability. By entering into the Raffle, all ticket purchasers agree to: (a) be bound by these Raffle Rules; and (b) release the Service Provider, the Foundation including its Board of Directors and Officers, Edmonton Oilers Hockey Corp., Oilers Entertainment Group Canada Corp., Oilers Entertainment Group Services Ltd., the National Hockey League, Canadian Bank Note and any event promoter and any presenting partner of the 50/50 Raffles, and each of their respective partners, subsidiaries and affiliates, together with the owners, employees, officers, directors, sponsors and agents of any of the foregoing (collectively, "Released Parties") from and against any and all claims, demands, injuries, losses and liabilities whatsoever arising out of the Raffle. The Foundation will administer the Raffle in good faith and in the best interests of the charitable beneficiaries but shall not have any liability in connection with any decisions made in connection with the Raffle. Released Parties: (i) make no warranty, guaranty or representation of any kind concerning any prize (or any portion thereof); and (ii) disclaim any implied warranty. The Foundation's failure to enforce any term of these Raffle Rules shall not constitute a waiver of that provision.

- 14. Cancellation:** The Foundation may rescind, cancel, amend or revoke the Raffle, subject to the prior approval of AGLC. Without limiting the generality of the foregoing, the Foundation reserves the right to cancel or modify the Raffle and/or these Official Rules, in whole or in part and without notice, if the Foundation determines that fraud or technical or other failures have threatened or destroyed the integrity of the Raffle.
