

**LAY'S® x DALLAS STARS EXPERIENCE SWEEPSTAKES ("SWEEPSTAKES")  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. BY ENTERING, PARTICIPANT AGREES TO BE BOUND BY THESE OFFICIAL RULES AND THE DECISIONS OF THE SPONSOR, WHICH SHALL BE FINAL IN ALL RESPECTS. ANY DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND PARTICIPANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

**1. ELIGIBILITY:** The Sweepstakes is open only to legal U.S. residents residing in select zip codes within Oklahoma and Texas (see Appendix at the bottom of these Official Rules for eligible zip codes), who are eighteen (18) years of age or older with a valid US driver's license or government issued photo ID at the time of entry. "Household Members" shall mean those people who share the same residence at least three (3) months during the twelve-month period preceding the start date of the Sweepstakes. Subject to all applicable federal, state and local laws and regulations.

**2. SWEEPSTAKES TIMING:** The Sweepstakes begins on December 15, 2025 at 12:00:00 a.m. Central Time ("CT") and ends on February 28, 2026 at 11:59:59 p.m. CT ("Sweepstakes Period"). The computer of the Administrator is the official time-keeping device of the Sweepstakes.

**3. HOW TO ENTER:** There are two (2) ways to enter the Sweepstakes as described below.

**A. TEXT MESSAGE:** During the Sweepstakes Period, use your SMS-enabled mobile phone to text **LaysStars** ("Keyword") to 23955. Next, follow the text prompts to complete your entry into the random drawing. By texting the Keyword, you will receive up to five (5) reply text messages about the Sweepstakes from the Sponsor. Additional reply text messages about the Sweepstakes may be sent to participant depending on participant's request(s) for help or to opt out (see below) or if they are deemed a potential winner (subject to verification). Participants must have a mobile phone with text messaging capabilities to enter by text message and may incur a standard text message charge from their wireless service provider for each text message sent and received. Check with your wireless service provider for details on these and any other applicable charges. Message and data rates may apply. Consent to receive reply texts is not a condition of entry. Your entry via text message is your electronic signature agreeing to these Official Rules at [lays.com/DallasStarsSweepstakes](https://lays.com/DallasStarsSweepstakes), and giving electronic written consent. Participants are solely responsible for any such wireless charges. Not all wireless carriers will participate. If you wish to opt out, text STOP to 23955. Text HELP to 23955 if you would like more information. Mobile entry is not required to submit an entry or win a prize in this Sweepstakes.

**B. **Limit one (1) entry per person/mobile number or mailing address per day, regardless of entry method.** A day is the twenty-four (24) hour period between 12:00:00 a.m. CT and end at 11:59:59 p.m. CT on the same day.

All entries must be properly received and recorded within the Sweepstakes Period to be eligible to win a prize. No other forms of entry are valid. Proof of submitting an entry does not constitute proof of delivery or entry. Each entry submission must be manually key stroked, hand written and/or manually entered by the individual participant. All automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or sweepstakes service) will be disqualified and all transmissions from such scripts, macros, bots or sweepstakes services or related phone numbers may be blocked. If it is discovered that a participant used multiple phone numbers, email addresses and/or mailing addresses, or manipulated such information, for the purpose of obtaining more than one (1) entry per day, such persons will be disqualified and all entries shall be deemed invalid and any prize awarded to them shall be forfeited.

All participants must have a valid email address. The name of the person submitting the entry into the Sweepstakes must be the authorized account holder of the email address used to enter, otherwise the entry may be deemed void. In the event of a dispute over the identity of a participant, the entry will be declared made by the authorized account holder of the email address. RANDOM DRAWING:** The potential winner will be selected in a random drawing on or about March 7, 2026 from among all eligible entries received by the Administrator, whose decisions are final in all matters relating to the Sweepstakes. Odds of winning depend on the number of eligible entries received.

**6. PRIZE DETAILS: One (1) prize is available to be awarded,** consisting of two (2) lower-level tickets and two (2) VIP Lounge passes (for use by winner and winner's guest) to the Dallas Stars home game scheduled to take place on March 16, 2026 ("Game"), a pre-Game penalty box experience during warmups (the "Gameday Experience"), and one (1) signed Dallas Stars jersey. The nature, duration and other details of the Gameday Experience and the player's signature on the jersey, shall be determined by the Dallas Stars and/or Sponsor, in their sole discretion. Prize Conditions below apply. Approximate Retail Value ("ARV"): \$1,492.00.

**Prize Conditions: Transportation, accommodations, parking, food and beverages (other than as included in VIP Lounge), gratuities, and all other expenses not specified herein are solely the winner's responsibility.** If the winner's guest is a minor in their state of residence, then winner must be the guest's parent or legal guardian and such minor guest must be accompanied by the winner at all times during the prize event. Game date is subject to change and/or cancellation in Sponsor's/NHL Entities' sole discretion. RELEASE OF LIABILITY:** By participating in the Sweepstakes, participants agree (a) to release and hold harmless the Released Parties from any and all claims or actions of any kind whatsoever for injuries, damages or losses to persons and property, including bodily injury and death, arising from or relating to such participant's participation or inability to participate in the Sweepstakes; (b) under no circumstances will participant be permitted to obtain awards for, and participant hereby waives all rights to claim, punitive, incidental, consequential, or any other damages, other than for actual out-of-pocket expenses; (c) all causes of action arising out of or connected with this Sweepstakes, or any prize awarded, shall be resolved individually, without resort to any form of class action; and (d) any and all claims, judgments, and award shall be limited to actual out-of-pocket costs incurred, excluding attorneys' fees and court costs. **10. DISPUTE RESOLUTION:** The parties waive all rights to trial in any action or proceeding instituted in connection with these Official Rules, including, without limitation, the Sweepstakes. The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in the State of Texas, and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury, and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to the Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in the State of Texas. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in the State of Texas. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of participant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court. The Sweepstakes is offered only in the United States and is governed by the laws of the state of Texas, and all claims must be resolved in the federal or state courts located in Collin or Dallas counties, Texas.

**11. GENERAL CONDITIONS:** Winner is solely responsible for any taxes on their prize, if any. Any difference between stated value and actual value will not be awarded. No cash equivalent or substitution of any prize is offered, except at the sole discretion of the Sponsor. No transfer of a prize is permitted. If terminated, Sponsor may, in its sole discretion, determine the winner from

among all eligible entries received up to time of such action in a manner as determined by the Administrator. This Sweepstakes is offered only in the eligible area listed in Section 1 and all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, participant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Texas, without giving effect to any choice of law or conflict of law rules. By entering, participants consent to the jurisdiction and venue of the federal, state and local courts for Collin or Dallas Counties, Texas.

Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on any website, social media platform or application and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.
