

**ROAD TO PUCK DROP SCAVENGER HUNT PRESENTED BY NAQVI INJURY LAW
OFFICIAL RULES**

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

Eligibility. The Road to Puck Drop Scavenger Hunt Presented by NAQVI Injury Law (the “Contest”) is open only to legal residents of Clark County, Nevada who are at least 18 years of age at the time of entry (the “Entrant”). The Contest is void elsewhere and where prohibited by law.
