## Pep's Pizza Company, LLC "Rinks that Rock the Haus" Sweepstakes Official Rules

NO PURCHASE, PAYMENT OR DONATION OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE, PAYMENT OR DONATION WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY. PEP'S PIZZA COMPANY, LLC "Rinks that Rock the Haus" (the "Sweepstakes") is only open to entrants who, as of the entry date, are permanent legal residents of the State of Minnesota (the "Sweepstakes Territory") who are at least eighteen (18) years old. In order to fully complete the form and be eligible to win the Prize, all entrants must submit a picture of their backyard rink. All eligible entries submitted during the Sweepstakes Period will be entered into a random drawing and eligible to win the Prize (described in Section 6 below).
