



## WASHINGTON CAPITALS SOCIAL GIVEAWAY RULES

### OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND OR SUBMISSION TO A SALES PROMOTION NECESSARY TO ENTER OR WIN A PRIZE. YOUR CHANCES OF WINNING A PRIZE WILL VARY WITH THE NUMBER OF VALID ENTRIES IN THE SWEEPSTAKES. TO ENTER, YOU MUST BE AT LEAST 18 YEARS OLD AND LEGALLY RESIDE IN WASHINGTON, D.C. OR PARTS OF MARYLAND AND VIRGINIA SPECIFIED IN THE OFFICIAL RULES. SWEEPSTAKES LIMITED TO WASHINGTON, D.C. AND SPECIFIED PARTS OF MARYLAND AND VIRGINIA. VOID ELSEWHERE AND WHERE PROHIBITED BY LAW. - 1. OBJECT OF THE SWEEPSTAKES:** As provided in more detail in these sweepstakes official rules (“**Official Rules**”), the Washington Capitals Social Giveaways (**each, individually in each instance, the “Sweepstakes”**) will from time to time award a pre-determined number of prizes to a pre-determined number of winners based on random drawing(s) of valid entries submitted via public social media tools, as directed in each instance through a post by Sponsor on a social media platform, such as X/Twitter, Instagram, Facebook, or TikTok containing the details of each Sweepstakes (the “**Sweepstakes Solicitation Post**”), before the applicable Entry Deadline.
- 2. SPONSORS:** Lincoln Hockey LLC dba Washington Capitals is the sponsor of the Promotion (“**Sponsor**”). Lincoln Holdings LLC dba Monumental Sports & Entertainment is the administrator of the Promotion (“**Administrators**”).
- 3. SWEEPSTAKES TERRITORY:** The Sweepstakes is limited to Washington, D.C. and parts of Maryland and Virginia within seventy-five (75) miles of the Capital One® Arena at 601 F Street NW, Washington, D.C. and located in any of the U.S. Postal Service ZIP Codes attached as Appendix 1 (“**Sweepstakes Territory**”). The Sweepstakes is void outside the Sweepstakes Territory or where prohibited by law. Entries by persons residing outside the Sweepstakes Territory will be void and not eligible for any Prize.
- 4. OFFICIAL RULES:** Persons entering the Sweepstakes agree fully and unconditionally to these Official Rules (“**Official Rules**”).
- 5. PERSONAL INFORMATION AND PRIVACY:** Persons entering the Sweepstakes hereby consent to the Monumental Sports & Entertainment Privacy Policy available at [www.monumentalsports.com/privacy](http://www.monumentalsports.com/privacy) (“**MSE Privacy Policy**”).
- 6. ELECTRONIC SIGNATURE: MARKING RADIO BUTTONS OR CHECK BOXES TO INDICATE ASSENT, OR ANY SIGNATURE WHETHER ELECTRONIC, DIGITAL, OR TYPED, SHALL INDICATE ACCEPTANCE OF THE OFFICIAL RULES AND MSE PRIVACY POLICY AND BE GIVEN THE SAME EFFECT AS A HANDWRITTEN OR ORIGINAL SIGNATURE.**
- 7. ELIGIBILITY:** The Sweepstakes is open only to natural persons who are legal residents of the Sweepstakes Territory who are at least 18 years of age when they enter. The following persons are not eligible to enter the Sweepstakes: (i) employees, officers, directors, members, partners, governors, contractors, and agents of the Washington Capitals, Monumental Sports & Entertainment, the National Hockey League or its teams, the Washington Wizards, the National Basketball League or its teams, the Women’s National Basketball Association or its teams, the NBA Development League or its teams, NBA Properties, Inc., NBA Media Ventures LLC, the National Hockey League or its teams, NHL Enterprises LP, NHL Enterprises Canada LP, Capital One Financial Corporation, any parent, subsidiary, any affiliate of any of the foregoing entities, any of the respective advertising, promotional, fulfillment and marketing agencies, wholesale distributors, retail licensees of any of the foregoing entities, or any contractors and other service agencies involved with the Sweepstakes (the



“**Sweepstake Entities**”); or (ii) members of the immediate family (parents, step-parents, children, step-children, siblings, or spouses) or households (persons who share the same residence for at least three months per year) of any employee, officers, directors, members, partners, governors, contractors, and agents of any of the Sweepstake Entities. 8. **ENTRY PERIOD AND DEADLINE:** There will be one (1) entry period in the Sweepstakes (“**Entry Period**”). The Entry Period will begin as of the time of release of the Sweepstakes Solicitation Post (the “**Start Time**”), and will end on or about 11:59 PM Eastern Time on the day three (3) days following the Start Time (the “**Entry Deadline**”). Entries must be received and recorded on or after the Start Time and no later than the Entry Deadline. The Sweepstakes will conclude after selection and confirmation of all Prize Winners.

9. **HOW TO ENTER:** To enter the Sweepstakes, complete the prompt described in the Sweepstakes Solicitation Post before the Entry Deadline for the applicable Entry Period (“**Entry**”). This is the only method for entering the Sweepstakes. No other forms of entry are valid. Your chances of winning a Prize will vary with the number of valid Entries made in the Sweepstakes.

**Entries must be received and recorded no later than the Entry Deadline for the applicable Entry Period. All Entries received or recorded before or after the Entry Period will be void.**

**Limit one (1) Entry per person during each Entry Period.** Entries by a person on e-mail or social media accounts may be treated as multiple Entries and Sponsor may deem that the Entry posted first in time is valid and disqualify any subsequent Entries.

Entries made using any robotic, macro, automatic, or programmed entry methods will be void. All Entries become the property of Sponsors and will not be returned.

**To enter, you must provide your own computer, mobile device, software, and Internet or mobile connection.** If entering with a mobile phone or other web-enabled device and using your wireless carrier’s network, standard data charges from your wireless carrier may apply. Check with your wireless service provider for details on these and any other applicable charges. Persons entering the Sweepstakes are solely responsible for any such wireless charges. You may be asked to consent to receiving commercial e-mails or mobile text messages and updates from Sponsors and their respective affiliates, but you are not required to consent to enter the Sweepstakes, and neither your eligibility for or chance of winning a Prize will be affected by whether or not you consent.

Sponsors are not liable to any party in connection with any dispute arising from or related to the identity of Entrant.



Sponsor reserves the right, but is not obligated, to review any Entry for non-compliance with or violation of these Official Rules and to reject, delete, disqualify, or otherwise exclude any Entry that, in their sole discretion, does not comply with or satisfy these Official Rules, is deemed to be inappropriate for publication, or is incomplete, illegible, garbled, or deceptive.

10. **PROHIBITED COMMENTS:** Entrants agree to comply with the terms of service and other rules applicable to the social media platforms used to enter the Sweepstakes, as set forth in Paragraph 4 of these Official Rules. In addition, Sponsors reserve the right in their sole discretion to remove any comment and disqualify the Entry associated with that comment that (i) is unlawful, misleading, or fraudulent, or is made for an unlawful purpose or in furtherance of illegal activities, including facilitating transactions in illegal goods or services and certain regulated goods or services, (ii) threatens or promotes terrorism or violent extremism, (iii) harasses, or threatens, promotes, encourages, or condones violence against, any person or group; (iv) harasses, or threatens, promotes, encourages, or condones violence against another person or group on the basis of race, ethnicity, national origin, caste, sexual orientation, gender, gender identity, religious affiliation, age, disability, or serious disease; (v) depicts or encourages sexual assault or violence; (vi) depicts nudity or intimate conduct, or is otherwise sexual, is profane, or vulgar; (viii) features or promotes child sexual exploitation, (ix) promotes or encourages suicide or self-harm; (x) violates the copyright, trademark, or other intellectual property rights of other persons; (xi) impersonates another person or use a fake identity to mislead, confuse, or deceive others; (xii) depicts inappropriate or excessive use of alcohol, tobacco, nicotine, marijuana, or others drugs, (vi) libels, slanders, defames, disparages, or denigrates a Sponsor, the Washington Wizards or its players and coaches, the NBA or its teams, players, and coaches, Capital One Financial Corporation, or any other person, or depicts the trademarks or other intellectual property of any of the foregoing in a false or unflattering manner; (vii) discloses, threatens to disclose, or encourages others to disclose private or confidential information, including social media handles, of any person other than Entrant, or (ix) supports, criticizes, or opposes any official or candidate for public office (“Prohibited Content”).
11. **NO OTHER OBLIGATION; NO CONFIDENTIAL INFORMATION:** By submitting an Entry, Entrant agrees that his/her Entry is gratuitous and made without restriction, and that it will not place Sponsors under any obligation other than as stated in these Official Rules, Entrant acknowledges that, by acceptance of his/her Entry, Sponsors do not waive any rights to use similar or related ideas previously known to Sponsors or developed by its employees or obtained from sources other than Entrant.
12. **SELECTING A WINNER:** Sponsors will select Winners at random from the pool of valid Entries on or about the day following the Entry Deadline ( the “**Drawing Date**”). Sponsors retain the right to not select Winners and to not award any Prize in the event there is an insufficient number of valid Entries, In the event that a Winner is disqualified or forfeits a Prize, Sponsor may in its sole discretion if time permits select an alternate Winner from among the remaining eligible Entries.
13. **NOTIFYING THE WINNERS:** Sponsors will notify each Winner by direct message using the email, social media handle, or other contact information associated with his or her Entry within two (2) business days after the Prize Date. To receive the Prize, Winner must respond and provide Sponsors with the Prize Affidavit, as defined in these rules, within the time and in the manner specified therein.
14. **PRIZES:** Unless otherwise disclosed in the Sweepstakes Solicitation Post, a total one (1) Entrant will be awarded one (1) Prize, during the Sweepstakes. - 15. REQUIREMENTS FOR WINNER TO RECEIVE PRIZE:** To receive a Prize, the Winner may be required to sign and return the following documents by e-mail or facsimile as directed by Administrators: An affidavit of eligibility and a release of publicity and liability provided by Sponsors together with proof of age and legal residence (“**Prize Affidavit**”). Sponsors must receive the signed and completed Prize Affidavit no later than twenty-four (24) hours after being notified by Administrators, failing which Winner will forfeit the Prize and Administrators may select an alternate Winner if time permits.
- 16. DELIVERY OF PRIZE TO PRIZE WINNER:** After receiving a timely and affirmed Prize Winner Affidavit, Administrator will deliver the Prize to Prize Winner via email provided by Prize Winner, or may be picked up at will call at Capital One Arena, or by other means as determined by Administrator in its sole discretion.
- 17. PRIZE LIMITATIONS – LIMIT ONE (1) PRIZE PER PERSON:** Winner may not assign or transfer a Prize or any part of a Prize and are not entitled to a substitute prize if unable or unwilling to accept or use the awarded Prize. Sponsors reserve the right to substitute any Prize (or a component thereof) with a prize of equal or greater value for any reason. Any costs and expenses associated with accepting and using a Prize that are not specified herein as being provided, including but not limited to transportation, food, beverage, delivery costs, and gratuities, are the sole responsibility of Winner. Some Prizes may require the Winner to provide his or her own computer, mobile device, software, and Internet or mobile connection, and for any charges associated therewith will be the sole responsibility of Winner. Prizes are awarded subject to unavailability, postponement, or cancellation to protect health or safety of the employees, contractors, and agents of a Sponsor or the public or to comply with emergencies, restrictions, and/or advisories of any kind by national, state, local, or municipal government and their agencies.

- 18. EVENT TICKET PRIZE RESTRICTIONS:** When indicated, Prizes may comprise tickets or passes for admission to an athletic exhibition, game, or other event (“**Event**”). Unless otherwise indicated, all Events for which tickets are awarded as Prizes will be held at Capital One Arena located at 601 F St. NW, Washington D.C. 20004 (the “**Venue**”). Travel expenses are not included in the prize. Each prize winner is solely responsible for all transportation, parking, accommodations, meals and beverages, incidental expenses and gratuities while attending the event. Any prize details not specified above will be determined by Sponsor in its sole discretion. Tickets and passes awarded as Prizes are subject to the terms and conditions set forth on those tickets and passes. Tickets and passes may not be transferred, resold or offered for resale, substituted, or redeemed except as they may expressly provide. Prize Winner and his/her guest(s) agree to comply with all applicable regulations of Venue in connection with the Prize. The operator of the Venue reserves the right to deny entry to the Venue or remove from the Venue any Prize Winner and/or any guest(s) who behave in a non-sportsmanlike, disruptive, or intoxicated manner, or with intent to annoy, abuse, threaten or harass any other person at the game, event or exhibition.
- 19. COVID-19 ADVISORY FOR INDOOR EVENTS.** Prize Winner and guests acknowledge and agree that the Event will be held indoors, that attendance at indoor gatherings is inherently dangerous due to the ongoing epidemic and pandemic of COVID-SARS-19, a highly contagious and communicable viral disease, and that there is the risk that by attending the Event they may contract COVID-19 and infect others. Having been advised of this Risk, Prize Winner and guests each hereby assume to the fullest



extent permitted by law any and all risks of illness, injury, or even death that may arise, directly or indirectly, in whole or in part, from attendance at the Event.

Prize Winner and guests acknowledge and agree that they will be required to wear face masks to be admitted to the Venue and during the time they attend the Event, as per the Order No. 2021-97 by the Mayor of the District of Columbia and regulations of the DC Department of Health, and that Sponsor, and the Venue may impose other requirements related to the COVID-SARS-19 epidemic / pandemic. Prize Winner and guests acknowledge and agree that Sponsor and the Venue have the right to deny them entry to the Venue or remove them from the Venue in the event that they fail to comply with any such to comply with any such orders, requirements, restrictions, or recommendations of federal, state, or local government, or of Sponsor or the Venue as may then be in effect.

Prize Winner and guests further acknowledge and agree that, even in the absence of a mandate by government, Sponsor or the Venue may be compelled to modify, postpone or cancel the Event with little (if any) advanced notice in response to economic and/or social conditions related to the COVID-SARS-19 epidemic / pandemic. In such case, Sponsor may in its sole discretion either allow Prize Winner to exchange the Prize for tickets to another Event, or to substitute an entirely different prize of comparable value. Such substitute prize shall constitute the entire liability of Sponsor to Prize Winner and guests.

20. **TAXES:** All taxes (if any), related to receipt and use of Prizes are the sole responsibility of the Winner. Should the ARV of the prize equal or exceed six hundred U.S. dollars (\$600.00), Winner will be required to provide a Social Security Number or a Taxpayer Identification Number to Sponsors for issuance of a 1099 Form. You hereby further irrevocably consent and waive any objection to being photographed, videotaped, interviewed, or otherwise recorded by Sponsors or their agents, and to the making and use by Sponsors or their agents of such photographs, videotapes, interviews, and other recordings ("**Recordings**"), in whole or in part, at any time, now and in the future, throughout the universe, for any purpose including but not limited to promoting the Sweepstakes, the Sponsors, and the Mystics Affiliates, by any means and in any and all forms of media, now known or hereafter devised, without any further consideration, notice, or approval except where and to the extent prohibited by law. Notwithstanding the foregoing grant of rights and consents, Sponsors have no obligation whatsoever to use or publicize you or any Entry Materials, or to make, use, or publicize any Recording. You acknowledge and agree that, as between you and Sponsors, Sponsors will be the owners of the Recordings and any and all rights including but not limited to copyright in the Recordings and the proceeds thereof throughout the universe, and you hereby assign and transfer to Sponsors any and all rights of any kind you may have in the Recordings, if any, without any further consideration, notice, or approval whatsoever. You further agree to sign any additional consents and releases as Sponsors may reasonably require to memorialize or confirm the provisions of this paragraph.
22. **ENTRANT'S REPRESENTATIONS AND WARRANTIES:** You hereby represent and warrant that you have complied with these Official Rules, that any and all information provided in your Entry and Prize Affidavit are true and complete, that he or she has complied with these Official Rules, and that any text, image, or other content associated with the Entry will not infringe or violate the rights of any other person or entity, and that your participation in the Sweepstakes, acceptance of a Prize, or participating in publicity in connection therewith will not be subject to or conflict with any contract or collective bargaining agreement to which you are a party. You are not required by Sponsors to post your Entry or



communicate that you are involved with the Sweepstakes to any social media platform, but if you do you shall comply with the Federal Trade Commission Guidelines Concerning the Use of Endorsement and Testimonials in Advertising. Sponsors reserve the right to disqualify and deny a Prize to you if you breach any of the foregoing representations and warranties.

23. **RELEASE AND INDEMNIFICATION:** You hereby agree to release, discharge, indemnify, defend, and hold harmless Sponsor, the Sweepstakes Entities, and the employees, officers, directors, members, partners, governors, contractors, representatives, and agents of any of the foregoing (collectively "**Released Parties**") from and against any and all liability, damage, claim, demand, cost, expense (including attorneys' fees), injury, loss, or damage of any kind to persons including but not limited to death, physical injury, or emotional injury, property, or rights of publicity or privacy, defamation, trademark infringement or dilution, copyright infringement, or portrayal in a false light, or any similar claim or cause of action in tort, contract or any other legal theory, now known or hereafter known in any jurisdiction throughout the world, whether unknown or unsuspected at this time ("**Claim**") arising from or in any way resulting from or related to, in whole or in part, directly or indirectly, from (i) entering or participating in the Sweepstakes or in any activity related to the Sweepstakes; (ii) acceptance, possession, receipt, use, or misuse of any Prize or any component thereof, or the unavailability of a Prize or inability to use a Prize due to actions taken by any person to protect the health or safety of its employees, contractors, and agents or the public, or to comply with emergencies, restrictions, and/or advisories of any kind by national, state, local, or municipal government and their agencies; (iii) an Entry or any material provided by you, including without limitation any allegation that such Entry or material infringes, misappropriates, or otherwise violates any of your personal rights or any personal rights of any other party; (iv) any violation by you of the Official Rules; (v) any statement, action, or failure to act by you during or in connection with your participation in the Sweepstakes; (vi) any breach or alleged breach by you of the representations and warranties made herein; and (vii) any violation of law, regulation, or ordinance.

emergency orders, restrictions, and/or advisories of any kind by federal, state, or local government and their agencies; or (xii) or any combination of any of the foregoing.

25. **SPONSOR'S DECISIONS – RIGHT TO DISQUALIFY, MODIFY, AND CANCEL:** All decisions by Sponsors and /or Administrators regarding the Sweepstakes, including interpretation of these Official Rules and exercise of discretion, will be final and binding in all respects. Sponsors and Administrators reserve the right in their sole discretion to disqualify entries that are inconsistent with these Official Rules or that are misleading, deceptive, or offensive. Sponsors also reserve the right to modify these Official Rules, and to cancel, terminate, modify, suspend, or make any change in the Sweepstakes for any reason, including without limitation to protect health or safety, and to comply with events, emergency orders, restrictions, and/or advisories of any kind by any local, municipal, state, or federal government or their agencies or the League, including but not limited to those set forth in Rule 25. Should any portion of the Sweepstakes be compromised by virus, worms, bugs, unauthorized human intervention or other causes that, in the sole opinion of Sponsors and Administrators, tend to impair submission of Entries or to compromise or corrupt administration, security, fairness or proper play of this Sweepstakes, then Sponsors and Administrators reserve the right in their sole discretion to suspend, modify or terminate the Sweepstakes and to select Winners from valid entries received before taking action, or to take other action as they may deem fair and equitable.
