

## SANDBAGGER SWEEPSTAKES OFFICIAL RULES

**NO PURCHASE NECESSARY. A purchase will not increase the chance of winning.**

**Eligibility.** The Sandbagger Sweepstakes (the “Sweepstakes”) is open only to legal permanent residents of Nevada who are at least 21 years of age at the time of entry (the “Entrant”). The Sweepstakes is void elsewhere and where prohibited by law.

**Prize Conditions.**

**All elements of the prize must be used on the date associated with the game ticket prize as described above or winner forfeits prize.** Date, time and location of prize elements to be determined by Sponsor at its sole discretion.
