KINGS NOTES

- Forward Trevor Moore (1-0=1) scored his 14th goal of the season, his fifth point (2-3=5) in his last five contests against Chicago, dating to March 19, 2024.
- Forward Alex Turcotte (1-0=1) scored his eighth goal of the season to double the Kings' lead in the first period. The native of Elk Grove, Ill., has now found the score sheet (1-2=3) in all three games against the Chicago Blackhawks this season.
 Defenseman Joel Edmundson (1-0=1) scored his sixth goal of the season and is now within a single tally of tying a career high he has set twice previously (2017-18 with STL; 2019-20 with CAR).
 Defenseman Vladislav Gavrikov (0-1=1) picked up his 21st assist of the campaign, his fourth point (1-3=4) in his last six games, dating to March 9 in Las Vegas.
 Defenseman Jordan Spence (0-1=1) contributed his 19th helper of the year, his fourth point (2-2=4) in as many all-time visits to United Center.
 Goaltender Darcy Kuemper turned aside 17 of the Blackhawks' 18 shots on goal to improve his record to 23-9-7 on the season.
