OFFICIAL CONTEST RULES

- 1. Sponsor and Administrator: 2023-24 COMMUNITY ALL-STAR CONTEST ("Contest") is sponsored and administered by Boston Professional Hockey Association, Inc. ("Sponsor").

One (1) winner will be chosen from all eligible entries approximately one day before each Boston Bruins regular season home game beginning October 11, 2023, and ending on April 16, 2024. The odds of winning a prize depend on total number of eligible entries received during the Contest Period (each an "Entry"). Sponsor cannot accurately predict the number of entrants who will participate in the Contest (each an "Entrant"). All times in this Contest refer to Eastern Time. By participating in the Contest, the Entrant acknowledges and agrees to be bound by these Official Rules, and agrees that all decisions of Sponsor, whose decisions are in its sole discretion, are binding and final. Failure to comply with these Official Rules will result in disqualification from the Contest.
- **3. Eligibility.** The Contest is open only to Entrants and their nominees who are legal U.S. residents of MA, CT, NH, RI, VT and ME who are at least 18 years of age on Monday, October 9, 2023.
