

2023 – 24 COMMUNITY ALL-STAR CONTEST

OFFICIAL CONTEST RULES

- **NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE WILL NOT IMPROVE YOUR ODDS OF WINNING.**

- **BY ENTERING THIS CONTEST, ENTRANT AGREES TO THESE OFFICIAL CONTEST RULES AS A BINDING CONTRACT.**

1. Sponsor and Administrator: 2023-24 COMMUNITY ALL-STAR CONTEST ("Contest") is sponsored and administered by Boston Professional Hockey Association, Inc. ("Sponsor").

2. General. The Contest begins at 8:00 am Eastern Time on Monday, October 9, 2023, and ends at 11:59 pm Eastern time on Tuesday, April 16, 2024, unless the Bruins proceed into the playoff post season at which point Sponsor reserves the right to extend the contest period (the "Contest Period"). One (1) winner will be chosen from all eligible entries approximately one day before each Boston Bruins regular season home game beginning October 11, 2023, and ending on April 16, 2024. The odds of winning a prize depend on total number of eligible entries received during the Contest Period (each an "Entry"). Sponsor cannot accurately predict the number of entrants who will participate in the Contest (each an "Entrant"). All times in this Contest refer to Eastern Time. By participating in the Contest, the Entrant acknowledges and agrees to be bound by these Official Rules, and agrees that all decisions of Sponsor, whose decisions are in its sole discretion, are binding and final. Failure to comply with these Official Rules will result in disqualification from the Contest.

3. Eligibility. The Contest is open only to Entrants and their nominees who are legal U.S. residents of MA, CT, NH, RI, VT and ME who are at least 18 years of age on Monday, October 9, 2023. Void where prohibited. Employees of Sponsor, Delaware North Companies, Inc. - Boston ("DNCB"), Massachusetts State Lottery, New England Sports Network ("NESN"), and their respective parent companies, subsidiaries and affiliates, and the officers, directors, agents, employees, advertising and promotion agencies and members of their immediate families (spouses, parents, children, and siblings and their spouses) of each of the foregoing are ineligible to enter.

4. How to Enter. No Purchase Necessary to Enter or Win. permission may result in the disqualification of the submission at the Sponsor's sole and absolute discretion. Sponsor will select the Entry with the best story from all the completed Entries (selected Entry is the "Winner").

Sponsor reserves the right to reject any Entry that it deems, in its sole discretion; to violate any of these content related requirements. By submitting an Entry (or accepting any prize), each Entrant and Winner understands and agrees that their Entry, including individual name may be posted online and further exploited by Sponsor for promotional purposes, without further compensation or review, and will not be returned. Winner and Sponsor will work together to determine an acceptable Bruins home game for the prize. The approximate value of the prize is \$444.00. Sponsor reserves the right in its sole discretion to substitute or award an alternative prize of approximately equal value with no further obligation to the winner. The prizes cannot be exchanged for cash and are nontransferable.

6. Determination of Winners. One (1) winner will be chosen from all eligible entries the around 24 hours prior to each Boston Bruins regular season home game beginning October 11, 2023, and ending on April 16, 2024. Sponsor will notify the Winner via the email provided in the Contest Entry form, and the Winner will be required to provide written consent of release giving Sponsor the irrevocable right without any further notice, review or consent to print, publish, broadcast, distribute, and use his or her photo, name and biographical information as news, publicity or information without any further compensation.

If any prize notification is undeliverable, if the Winner is not responsive within 24 hours of the initial notification, or in the event of non-compliance with any of these requirements, the prize will be forfeited and an alternate Winner will be selected from the remaining pool of eligible Entries.

Sponsor will have complete discretion over the interpretation of these Official Rules, of administration of the Contest, and of selection of the Winners. Sponsor's decisions are final, binding and conclusive on all matters related to the Contest.
