OFFICIAL CONTEST RULES

One (1) winner will be chosen from all eligible entries by November 29, 2024. The odds of winning a prize depend on the total number of eligible entries received during the Contest Period (each an "Entry"). Administrator and Sponsor cannot accurately predict the number of entrants who will participate in the Contest (each an "Entrant"). All times in this Contest refer to Eastern Time. By participating in the Contest, the Entrant acknowledges and agrees to be bound by these Official Rules, and agrees that all decisions of Sponsor, whose decisions are in its sole discretion, are binding and final. Failure to comply with these Official Rules will result in disqualification from the Contest.
- 3. Eligibility: Entrants will nominate a public school in the Greater Boston area that serves grades 4 through 7. The Contest is open only to Entrants and their nominees who are legal U.S. residents of MA. Entrants must be least 18 years of age as of Friday, November 22, 2024. Nominees must be public schools serving grades 4 through 7 within the Greater Boston area within 35-mile radius of Warrior Ice Arena in Brighton, MA. Nominated schools must have both students and teachers registered for the Future Goals™ Program and be actively using the program prior to the STEM Day. Parents of winning students must be willing to complete liability and media waivers to be featured in a post-STEM Day highlight video that will be shown on Bruins social media accounts, in-game and on Bruins Academy The Show. Void where prohibited. Employees of Sponsor, Administrator, Delaware North Companies, Inc. Boston ("DNCB"), New England Sports Network ("NESN"), and their respective parent companies, subsidiaries and affiliates, and the officers, directors, agents, employees, advertising and promotion agencies and members of their immediate families (spouses, parents, children, and siblings and their spouses) of each of the foregoing are ineligible to enter.

Entrants are encouraged to include up to three (3) supporting documents including one (1) letters of support, and two (2) student testimonials, and any other relevant materials that demonstrate their commitment to STEM education and their vision for future STEM initiatives. Judging of all Entries and selection of the winner will be made by Sponsor, Administrator, and Future Goals. By submitting an Entry, each Entrant represents that the Entry is true and correct, and that he or she is authorized to submit such Entry. Only one Entry per person.

Administrator reserves the right to reject any Entry that it deems, in its sole discretion; to violate any of these content related requirements. By submitting an Entry (or accepting any prize), each Entrant and Winner understands and agrees that their Entry, including individual name may be posted online and further exploited by Administrator for promotional purposes, without further compensation or review, and will not be returned. Administrator will determine an acceptable date for the prize. The approximate value of the prize is \$3,500. Administrator reserves the right in its sole discretion to substitute or award an alternative prize of approximately equal value with no further obligation to the winner. The prizes cannot be exchanged for cash and there are no date substitutions. Transfer of any prize is prohibited unless approved by Administrator.
- **6.** <u>Determination of Winners:</u> One (1) winner will be chosen from all eligible entries by November 29, 2024. Administrator will notify the Winner via the email provided in the Contest Entry form, and the Winner will be required to provide written consent of release giving Administrator the irrevocable right without any further notice, review or consent to print, publish, broadcast, distribute, and use his or her photo, name and biographical information as news, publicity or information without any further compensation.

If any prize notification is undeliverable, if the Winner is not responsive within 48 hours of the initial notification, or in the event of non-compliance with any of these requirements, the prize will be forfeited, and an alternate Winner will be selected from the remaining pool of eligible Entries.
