(a) **Entry on Twitter/X.** Participant may be required to have a Twitter/X account, which is free. **Participants may enter by visiting the Official Detroit Red Wings Twitter/X page during each Entry Period and tweet which DRW player will score the first goal of the game along with the following #DRWFirstGoal and #Contest.** Limit one (1) entry per person during each Entry Period. Any attempt by any Participant to obtain more than the stated number of entries by using multiple/different identities, registrations or any other methods will void that Participant's entries and that Participant may be disqualified. Multiple Participants are not permitted to share the same Twitter accounts. All entries submitted become the sole property of the Sponsor and will not be acknowledged or returned. If a Detroit Red Wings Player does not score a goal during the Game on the Drawing Date, no winner will be selected. There will be no roll-over of non-winning entries to successive Entry Periods. The potential Winner(s) will be notified via e-mail or telephone. If a potential winner does not respond within seventy (72) hours following delivery of the e-mail notification or telephone message notifying the potential winner of his/her selection, if he/she is found to be ineligible, if he/she cannot or does not comply with these Official Rules, or if his/her prize or prize notification is returned as undeliverable, such potential Winner will be disqualified and an alternate potential Winner will be selected at the sole discretion of Sponsor.
