Administrator reserves the right to reject any Entry that it deems, in its sole discretion; to violate any of these content related requirements. Winners (schools) are eligible to win one (1) prize each only. The prize includes a monetary donation to their school and a 40-minute BFit School Assembly at their school, which teaches them how to live a happy, healthy lifestyle by emphasizing the importance of proper nutrition, kindness, determination, and movement through the game of hockey. The BFit team will lead kids through 12 minutes of movement exercises showing them good exercises to maintain a healthy lifestyle. To close out the program, there will be a student vs. teacher shootout to engage participation in hockey. Ten (10) winners will receive a \$10,000 donation and one (1) grand prize winner will receive a \$100,000 donation. The best Entry will receive the grand prize. Administrator will determine three dates for the school assembly for winners to select from. Should the Boston Bruins Foundation need to cancel the BFit School Assembly due to weather, staffing, or additional conflicts, the school will be given three alternative dates to select from and the Boston Bruins Foundation will work in good faith with the winning school to reschedule the BFit School Assembly. Administrator reserve the right in their sole discretion to substitute or award an alternative prize of approximately equal value with no further obligation to the winner. The prizes cannot be exchanged for cash and there are no date substitutions. Transfer of any prize is prohibited unless approved by Administrator.
- 6. <u>Determination of Winners:</u> Eleven (11) winners will be selected throughout the Contest Period by a panel of judges from Administrator the winner will be the Entry that has the best answers to the questions "Why should the Boston Bruins visit your school?" and "Why should your school receive a donation towards Health and Wellness from the Boston Bruins Foundation?" Winners will be given three (3) date options to choose from in the event that the three (3) dates do not work, the winner will have to forfeit the prize, and another winner will be chosen from the remaining valid Entries based on the judging criteria listed above and given the three (3) dates. This will continue until a winner is locked in based on the available dates. Administrator will notify the winner via the email provided in the Contest Entry form, and the Winner will be required to provide written consent of release giving Administrator the irrevocable right without any further notice, review or consent to print, publish, broadcast, distribute, and use his or her photo, name and biographical information as news, publicity or information without any further compensation.
