

KNIGHTLY PREDICTIONS SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY. A purchase will not increase the chance of winning.

Eligibility. Knightly Predictions Sweepstakes (the “Sweepstakes”) is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least 18 years of age at the time of entry (the “Entrant”). The Sweepstakes is void elsewhere and where prohibited by law.

Sponsor’s servers and clock shall serve as the official clock for the Sweepstakes and Entrants’ proof of submission does not constitute proof of receipt by Sponsor.

How to Enter. During the Sweepstakes Period, visit the Vegas Golden Knights Mobile App, sign into your Vegas Golden Knights Mobile App account (“Account”), and answer all of the Knightly Prediction questions (8 total) and submit your answers before the start of a Vegas Golden Knights game. To access the Knightly Prediction questions in the Mobile App, click on the menu button in the top left corner and then click on “Knightly Predictions” in the Game section of the dropdown menu. The Vegas Golden Knights Mobile App is free, but only available in the App Store or Google Play (for iOS/Android). In order to complete the entry process, Entrant must have an Account. To create an Account, click on “Sign In/Sign Up” in the Mobile App and complete the sign up form. There is no fee or charge for to create an Account. Your foregoing actions and provided information in entering the Sweepstakes shall hereinafter be referred to as “Submissions”.

Provided an Entrant’s Submission conforms to these Official Rules, upon completing a Submission, each Entrant will receive one (1) entry into the Sweepstakes. **There is no limit on the number of times an Entrant may enter the Sweepstakes during the Sweepstakes Period, but limit one (1) Submission per game per person during the Sweepstakes Period and one (1) prize per person.**

Winner Selection.

The Entrant with the third highest overall score at the end of the Sweepstakes Period will be the potential Third Place Winner.
