

# Just BARE Chicken presents Ladies Night with the Wild Official Sweepstakes Rules

NO PURCHASE, PAYMENT OR DONATION OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE, PAYMENT OR DONATION WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

**1. ELIGIBILITY.** Just BARE Chicken's Ladies Night with the Wild Sweepstakes (the "Sweepstakes") is only open to entrants who, as of the entry date, are permanent legal residents of the States of Minnesota, North Dakota, South Dakota, Iowa, Illinois or Wisconsin who are at least twenty-one (21) years old. The Sweepstakes is void outside the States of Minnesota, North Dakota, South Dakota, Iowa, Illinois or Wisconsin and where prohibited or restricted by law. Employees, officers and directors of Minnesota Wild Hockey Club, L.P. ("Wild") and JBS USA Food Company Holdings d/b/a Pilgrim's Pride ("Sponsor") (Wild and Sponsor collectively the "Sweepstakes Entities"), their respective parents, subsidiaries, affiliates, divisions, advertising and promotion agencies, and the immediate families (defined as parents, spouses, children, siblings, grandparents, and their respective spouses) or members of the same household (whether related or not) of each such employee, officer and director, are not eligible to enter. The Sweepstakes, and any website pages and advertisements relating thereto, is intended for viewing only within the eligible Sweepstakes territory, and entrants must be present in the eligible Sweepstakes territory at the time they enter.

**2. TIMING.** The Sweepstakes entry period begins at 12:00 p.m. Central Time ("CT") on Sunday, January 7, 2024, and ends at 12:00 p.m. CT on Thursday, January 11, 2024 ("Entry Period"). Wild's computer is the official timekeeping device for the Sweepstakes.

**3. HOW TO ENTER.** Entries will be collected online via the Minnesota Wild website, limit one (1) entry per person.

- a. **TO ENTER ONLINE:** During the Entry Period, go to [www.wild.com/JBCLadiesNight23](http://www.wild.com/JBCLadiesNight23) to find the Official Entry Form. Fully complete the Official Entry Form by entering your first name, last name and email address. All entrants must agree to these Official Rules by checking the box provided at the bottom of the Official Entry Form agreeing to these terms and conditions before they may submit their entry. All eligible entrants who fully complete and enter the Official Entry Form during the Entry Period will be entered into a random drawing to win the prize (described in Section 6 below).
- b. **TO ENTER VIA MAIL: LIMIT:** One (1) mail in entry per person and address (physical or email) in the Sweepstakes. All entries must be received by Wild during the Entry Period and become the exclusive property of the Sweepstakes Entities. None will be acknowledged or returned. All entrants and entries subject to verification prior to the awarding of a prize, as are the eligibility, age and other claims of/information provided by a potential prize winner. **4. AGREEMENT TO OFFICIAL RULES AND DECISIONS.** By participating in the Sweepstakes, each entrant fully and unconditionally agrees to be bound by and accepts these Official Rules and the decisions of the Sweepstakes Entities (including, without limitation, decisions regarding eligibility of entries, the selection of entrants and the winners, and the awarding of prizes), which are final and binding in all respects.

## 5. SELECTION; ODDS; NOTIFICATION.

On or about Thursday, January 11, 2024 Wild will randomly select twenty (20) potential winners from among all eligible entries received by Wild during the Entry Period. **Note: Winner and each of winner's guest MUST be over the age of twenty-one (21). Winner must be able to attend the Friday, February 17, 2023 Minnesota Wild home game at Xcel Energy Center, located at 199 W Kellogg Blvd, St Paul, MN 55102 (the "Arena"), to accept the prize; if the winner is under the age of twenty-one (21) and/or unable to attend the game, that entrant forfeits his or her right to the prize and another winner will be selected from among all eligible entries.** Winner is not required to accept the one (1) additional guest ticket included in the prize, however, unclaimed guest tickets will not be substituted, refunded or transferred except in Wild's sole discretion.

Odds of winning a prize depend on the number of eligible entries received by Sweepstakes Entities during the Entry Period.

The entrant selected must comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner will be notified by phone or email as provided in the Entry Form. The potential winner may be required to execute and return to Wild a notarized Affidavit of Eligibility, a Liability Release, and a Publicity Release (except where prohibited by law) (an "Affidavit/Release") in the form(s) provided by Wild in order to claim his/her prize. The Affidavit/Release must be returned to Wild by the date and/or time indicated within the Affidavit/Release. If the potential winner cannot be contacted within two (2) days of the first attempt to contact him/her, or if the potential winner fails to return the Affidavit/Release within the specified time, or if any prize or prize notification is returned as undeliverable, or if the potential winner is found to be ineligible, or if the potential winner does not comply with the Official Rules, then the potential winner may be disqualified and an alternate winner selected by Wild in his/her place at random from among all eligible non-winning entries received by Wild for the Sweepstakes. In such event, an alternate potential prize winner will be notified as described above and will be required to return the required documents to Wild as described above; provided, however, Wild may alter the above timing to meet its Sweepstakes schedule.

**6. PRIZE.** Subject to the terms and conditions of these Official Rules, twenty (20) prize packages will be awarded.

Each of the twenty (20) winners will receive a Ladies Night Out prize package consisting of two (2) suite tickets (one (1) ticket for winner and one (1) ticket guest of winner) to the Minnesota Wild vs. Arizona Coyotes game on Saturday, January 13, 2024 at the Arena. Food and beverage will be provided in the suite during the game. The approximate retail value ("ARV") of the two (2) suite ticket package, including food and beverage, is three hundred fifty dollars (\$350.00).

**Winner and winner's guests MUST be over the age of twenty-one (21) to gain entry to the event(s). Wild reserves the right, in its sole discretion, to deny entry to the pre-game social and/or to revoke the suite tickets of winner and one (1) of his/her guests if Wild suspects that one or more of the individuals are under the age of twenty-one (21).**

Any costs not specifically noted above in this Section 6 will be the sole responsibility of the prize winner and/or winner's guests, including but not limited to, any costs associated with travel in connection with the prize, including but not limited to travel to and from the Xcel Energy Center in St. Paul, MN, as well as parking.

All prizes must be accepted as awarded, and prize is awarded "AS IS" with no warranty, representation, or guarantee, express or implied, in fact or in law, made by Sweepstakes Entities or for which Sweepstakes Entities shall be liable, including, without limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE. No substitution, assignment, refund or transfer of a prize is permitted, except by Wild, who reserves the right to substitute a prize (or a component thereof) with another prize (or component thereof) of greater or equal value, including cash, if a prize is not available for any reason as determined by Wild in its sole discretion. **8. DISPUTES.** Entrant agrees that: (a) any and all disputes, claims, and causes of action arising out of or connected with this Sweepstakes, or any prizes awarded shall be resolved individually, without resort to any form of class action, and solely and exclusively in a federal or state court located in Minneapolis or St. Paul, Minnesota; entrant submits to sole and exclusive personal jurisdiction to said courts in the State of Minnesota for any such dispute and irrevocably waives any and all rights to object to such jurisdiction; (b) any and all claims, judgments, and awards shall be limited to actual out of pocket costs incurred, including costs associated with entering this Sweepstakes but in no event attorneys' fees; and (c) under no circumstances will entrant be permitted to obtain awards for and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of
