OFFICIAL CONTEST RULES

Should the Boston Bruins compete in the 2026 postseason, Contest will run until the Boston Bruins are no longer active in the NHL postseason (collectively the "Contest Period"). One (1) winner will be chosen from all eligible entries approximately one day before each Boston Bruins regular season home game beginning October 9, 2024, and ending when the Bruins are no longer active in the NHL postseason. The odds of winning a prize depend on the total number of eligible entries received during the Contest Period (each an "Entry"). Sponsor cannot accurately predict the number of entrants who will participate in the Contest (each an "Entrant"). All times in this Contest refer to Eastern Time. By participating in the Contest, the Entrant acknowledges and agrees to be bound by these Official Rules, and agrees that all decisions of Sponsor, whose decisions are in its sole discretion, are binding and final. Failure to comply with these Official Rules will result in disqualification from the Contest.

Sponsor will determine an acceptable Bruins home game for the prize. Winner will also be shown on Hub Vision (Jumbotron) during the prize game, highlighting that they were that game's Community All-Star. The approximate value of the prize is \$147 per ticket, \$588.00 total. Sponsor reserves the right in its sole discretion to substitute or award an alternative prize of approximately equal value with no further obligation to the winner. The prizes cannot be exchanged for cash and there are no date or seat substitutions. Transfer of any prize is prohibited unless approved by Sponsor.
- **6.** <u>Determination of Winners:</u> One (1) winner will be chosen from all eligible entries around 24 hours prior to each Boston Bruins regular season home game beginning October 9, 2024, and ending when the Bruins are no longer active in the NHL regular season or postseason. Sponsor will notify the Winner via the email provided in the Contest Entry form, and the Winner will be required to provide written consent of release giving Sponsor the irrevocable right without any further notice, review or consent to print, publish, broadcast, distribute, and use his or her photo, name and biographical information as news, publicity or information without any further compensation.

If any prize notification is undeliverable, if the Winner is not responsive within 24 hours of the initial notification, or in the event of non-compliance with any of these requirements, the prize will be forfeited and an alternate Winner will be selected from the remaining pool of eligible Entries.
