Au Coeur de nos Célébrations Contest

OFFICIAL RULES

1. Contest Period

The Au Coeur de nos célébrations Contest (the "**Contest**") begins at 9:00 a.m. Eastern Time ("**ET**") on **November 7, 2023** and ends at 9:00 a.m. ET on **December 8, 2023** (the "**Contest Period**"). By participating in the Contest, each entrant agrees to abide by and be bound by these Official Rules and all decisions of the Club de hockey Canadien, Inc. ("**Sponsor**"), which shall be final and binding, without right of appeal, in all matters relating to this Contest and the awarding of the prize(s), including without limitation eligibility and/or disqualification of entries.

By entering the Contest, each entrant acknowledges and agrees that the Contest is in no way administered by Canadian Imperial Bank of Commerce or any of its subsidiaries and affiliates ("**CIBC**"), and that Club de hockey Canadien, Inc. is fully responsible for the conduct and administration of the Contest, including the selection of winners.

2. Eligibility

The Contest is open to legal residents of Quebec who have reached the age of majority in Quebec as of the date of entry.

Odds of being selected depend on the number of eligible entries received during the Contest Period.

6. Selected Entrant Verification and Prize Claim Conditions

Selected entrant(s) will be notified by email at the email address provided at the time of entry.
