Arizona Coyotes SMS Sweepstakes

OFFICIAL RULES

NO PURCHASE REQUIRED TO ENTER OR WIN.

YOU MUST BE 18 YEARS OF AGE OR OLDER TO ENTER.

- 1. **ELIGIBILITY**: The Arizona Coyotes SMS Sweepstakes (the "Sweepstakes") is open only to legal residents of the United States who are 18 years of age or older. Entrants must be located in one of the fifty (50) United States or the District of Columbia to be eligible. Employees, agents, officers, directors, members, managers, and owners of the IceArizona Hockey Co, LLC d/b/a Arizona Coyotes (the "Coyotes"), IceArizona Holdings LLC, IceArizona AHL Co LLC, the Arizona Coyotes Foundation, the National Hockey League (the "NHL") and its member clubs, and each of their respective parents, subsidiaries, affiliates, owners, members, directors, managers, officers, employees and their advertising agencies, promotional partners and prize providers associated with this Sweepstakes (each a "Promotion Entity" and collectively the "Promotion Entities"), and their immediate family members (spouses, domestic partners, parents, legal guardians, grandparents, grandchildren, siblings, children and "step" of each) and those individuals living in their same household are not eligible to enter or win. The Sweepstakes is subject to federal, state, and local laws and regulations and is void where prohibited.
- 2. **SPONSOR**: The Sweepstakes is sponsored by the Coyotes (together with its affiliates, the "Sponsor").
- 3. **AGREEMENT TO OFFICIAL RULES**: Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these official rules ("Official Rules") and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.

The Entries that are submitted prior to or after the Entry Periods will be disqualified. Additional Entry Periods may be added following the regular season, which will commence on Thursday at 12:01 a.m. and end on the following Wednesday at 11:59 p.m.

HOW TO ENTER: In order to enter the Sweepstakes and be eligible for the corresponding Prize, you must receive SMS https://www.nhl.com/coyotes/fans/sms opt-in to texts via https://my.community.com/arizonacoyotes?t=Join. The winner will be selected at random from the pool of entrants who follow and complete the instructions correctly. No mechanically reproduced, illegible, forged, software-generated, other automated, or incomplete entries will be accepted. The use of any device to automate the entry process is prohibited. Sweepstakes entries will be deemed null and void and will be rejected if not submitted through authorized, legitimate channels. All late, lost, or incomplete entries are not considered valid entries. There is a limit of one (1) entry per person per Entry Period, regardless of entry method. For the avoidance of doubt, an entrant who wins a Prize in any Entry Period shall not be eligible to win a Prize in any other Entry Period. Entrants submitting multiple entries will be disqualified and not entered into the drawing. ENTRANTS MUST BE 18 YEARS OF AGE OR OLDER TO BE ELIGIBLE.

- 5. **SPONSOR OWNERSHIP OF ENTRIES**: All entries and materials submitted to Sponsor in connection with the Sweepstakes (collectively, "Entry Materials"), along with all copyright, trademark and other proprietary rights associated therewith, become the property of Sponsor upon submission, and Entry Materials will not be returned to any entrant.
- 6. **DRAWING AND ODDS OFWINNING**: As soon as practicable following each Entry Period, the Sponsor will select potential winners in a random drawing of all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via SMS or email. If a potential winner does not respond within twenty-four (24) hours of first contact (or, if different, as set forth in the SMS or email winning notification), or is not eligible or does not wish to accept the prize (as described below), the Sponsor may disqualify that potential winner and select an alternate potential winner in his/her place at random from the remaining eligible entries received. For certain prizes, Sponsor will select potential winners at random based on the additional criteria specified in the "Prizes" section below.
- 7. REQUIREMENTS OF POTENTIAL WINNERS: A potential winner may be required to execute prize claim documents, including without limitation a Waiver and Release, Affidavit of Eligibility, a Liability Release and, where imposing such condition is legal, a Publicity Release (collectively, "Prize Claim Documents"). Sponsor. If any potential prizewinner fails to return such documents within the prescribed time, if any potential prizewinner is found to be ineligible, or if they do not comply with these Official Rules, then such potential prizewinner may be disqualified and an alternate prizewinner may be selected from the remaining eligible entries during the Sweepstakes Period. All applicable U.S., federal, state, and local taxes, duties, or other taxes or fees are the sole responsibility of the prizewinner, who may be issued a 1099 IRS tax form for the ARV of any awarded prize.

- 8. **PRIZES**: The prizes (each, a "Prize") that will be awarded for each Entry Period will consist of one (1) Arizona Coyotes autographed item with approximate retail value (ARV) of \$150. All prize details will be determined by the Sponsor in its sole discretion. Prizes are not transferable or refundable and must be accepted as awarded by winner. No cash or other substitution may be made, except by the Sponsor, who reserves the right to substitute a prize (or component thereof) with another prize (or component thereof) of equal or greater value if the prize is not available for any reason as determined by the Sponsor in its sole discretion. Winner is responsible for all costs and expenses associated with prize acceptance and use not listed above as being provided, including but not limited to meals, incidentals, ground transportation, souvenirs, taxes, fees, surcharges. Prizes will be reported as income to the winner and the winner will be responsible for all federal, state, and local taxes associated with the receipt of any prize.
- 9. **PRIVACY AND PUBLICITY**: All information submitted by entrants in the Sweepstakes will be treated according to Sponsor's Privacy Policy, available at https://www.nhl.com/coyotes/team/privacy-policy. Additionally, except where prohibited, participation in the Sweepstakes constitutes such prizewinner's permission for the Sponsor and its respective related entities and agents to use said prizewinner's name, photograph, likeness, statements, biographical information, voice, and city and state for all purposes and in all forms of media, in perpetuity, without further notice or compensation.
- 10. **GENERAL CONDITIONS**: In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, the Sponsor may, in its sole discretion, either (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules or (b) award the prizes at random from among the eligible entries received up to the time of the impairment. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be engaging in behavior that (as determined by the Sponsor in its sole discretion) is obnoxious or threatening, illegal, that is intended to annoy, abuse, or threaten any other person, or otherwise violates these Official Rules, the Sponsor reserve the right to deem such prizewinner ineligible and, if applicable, invalidate the Prize. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

12. **GOVERNING LAW AND DISPUTE RESOLUTION**: AS A CONDITION OF ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES THAT ANY AND ALL DISPUTES, CLAIMS, CONTROVERSIES, OR CAUSES OF ACTION ARISING OUT OF OR RELATING TO THE SWEEPSTAKES OR ANY PRIZE AWARDED (EACH, A "CLAIM") SHALL BE (I) ARBITRATED ON AN INDIVIDUAL BASIS ONLY, AND SHALL NOT BE CONSOLIDATED OR JOINED WITH OR IN ANY ARBITRATION OR OTHER PROCEEDING INVOLVING A CLAIM OF ANY OTHER PARTY, AND (II) SETTLED BY BINDING ARBITRATION IN MARICOPA COUNTY, ARIZONA BEFORE A SINGLE ARBITRATOR APPOINTED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS THEN GOVERNING RULES AND PROCEDURES, AND JUDGMENT ON THE AWARD RENDERED BY THE ARBITRATOR MAY BE ENTERED BY ANY COURT HAVING JURISDICTION THEREOF.

THE INVALIDITY OR UNENFORCEABILITY OF ANY PROVISION OF THESE RULES SHALL NOT AFFECT THE VALIDITY OR ENFORCEABILITY OF ANY OTHER PROVISION.

IN NO EVENT WILL PROMOTION ENTITIES BE RESPONSIBLE OR LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND, INCLUDING DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES ARISING OUT OF PARTICIPANT'S PARTICIPATION IN THE SWEEPSTAKES.
