

## Sweepstakes Official Rules

### NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

1. NO PURCHASE NECESSARY TO ENTER OR WIN. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this sweepstakes.

3. ELIGIBILITY: Open to permanent legal residents of the 50 United States, the District of Columbia and Canada who are eighteen (18) years of age or older, at time of entry. Employees of Sponsor, its affiliates, subsidiaries, advertising, promotion, and fulfillment agencies, and members of the immediate family or household of each of the foregoing are not eligible to participate. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited or restricted by law.
