

## 30 DAYS OF GIVEAWAYS RULES AND REGULATIONS

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN FLORIDA AND NEW YORK.**

- 1. ELIGIBILITY:** Pittsburgh Penguins' 30 Days of Giveaways ["Sweepstakes"] is open to legal residents of the United States and the District of Columbia who are at least eighteen (18) years of age at the time of entry. Officers, directors, partners, members, shareholders, owners, employees and agents of Pittsburgh Penguins LP ["Sponsor"] and its parent companies, subsidiaries, affiliates, advertising and promotional agencies, and their immediate family members (spouse, parent, child and sibling and their respective spouses) and household members (whether or not related) are ineligible to participate in the Sweepstakes.
- 2. TO ENTER:** The Sweepstakes begins on March 18, 2024 at 8:30 a.m. EST and ends on April 16, 2024 at 5:00 p.m. EST (the "Sweepstakes Period"). There are two (2) ways to enter the Sweepstakes.

(A) Auto Renew. 2023-24 Penguins season ticket holders ["Current Holder"] enrolled in Auto Renew for the 2024-25 season (and subsequent seasons) will be entered into the Sweepstakes. The Current Holder will receive one (1) entry per day during the Sweepstakes Period for each day after enrollment has occurred. With Auto Renew, a 20% deposit will be taken on Monday, March 18. Remaining monthly installments will be automatically charged to your card on file the first business day of each month (May-Dec).

(B) Alternate Entry. To receive an entry without making a purchase (an "Alternate Entry"), print your name, address, city, state, zip code and telephone number on a 4x6 note card and mail the card to: Pittsburgh Penguins, 1001 Fifth Avenue, Pittsburgh, PA 15219, Attn: 30 Days of Giveaways. Alternate Entries must be post-marked by April 14, 2024 and received by April 16, 2024. Only one (1) Alternate Entry per envelope, and entrant will receive one (1) entry per day during the Sweepstakes Period for each day after the mailing has been received. Facsimiles, photocopies or mechanical reproductions of Alternate Entries will be void. Proof of sending or submitting an Alternate Entry is not proof of receipt of such Alternate Entry by Sponsor. Sponsor is not responsible for lost, late, invalid, unintelligible, incomplete, mutilated, garbled, postage-due or misdirected entries, which will be disqualified. Only one (1) prize per person. Non-winning entries will not roll-over into subsequent drawings. The potential Winner(s) will be notified via e-mail or telephone. All potential Winners may be subject to verification of eligibility, and may be required to sign and return an Affidavit of Eligibility/Release of Liability/Prize Acceptance Form.
